AWARDS AND PRESENTATIONS

President Chris Hilbert, along with all members of Council, proclaimed Richmond as a Purple Heart City in recognition of the patriotic public services of the many men and women throughout the nation who have earned the Purple Heart Award.

Members of the Military Order of the Purple Heart's Patriot Member of the Greater Richmond Chapter presented a plaque and a Purple Heart recipient reserved parking sign to Council.

Councilor Ellen Robertson, along with all members of Council, recognized the Richmond Police Department Fourth Police Precinct for their work on behalf of the community.

Councilwoman Reva Trammell, along with all members of Council, recognized Officer Jerry Baskette and Officer Alice Snell, both with the Richmond Police Department's Richmond Community Assisted Public Safety Program, and 1st Police Precinct Officer Debbie Allen, 2nd Police Precinct Officer Monica Powell, 3rd Police Precinct Officer Hawkins Wortham and 4th Police Precinct Officer Frank Misiano for helping to make the city a safer place.

CITIZEN COMMENT

Marcus Squires addressed Council regarding his replacement on the Richmond Sister Cities Commission.

A copy of the information provided has been filed.

Jennifer Elmore addressed Council regarding the proposed downtown redevelopment project and the impact it will have on the city's homeless population.

Trina Jones Louis addressed Council alleging that she overheard inappropriate comments from a member of the mayor's staff regarding protesters of the shooting death of Marcus David-Peters.

Denise Banks, member of the Laborers' International Union of North America (LiUNA), asked Council to support the use of local city laborers in the proposed downtown redevelopment project.

Councilor Kim Gray stated that she supports utilizing local city laborers in economic development projects.

Christopher Tatum, member of LiUNA, urged Council to require that the proposed downtown redevelopment project agreement include a workforce requisite for local job participation.

DeMorrise Wyatt, member of LiUNA, explained the success he has had since joining LiUNA.

Councilor Michael Jones asked for the names of businesses that provide services for economic development projects and the process by which companies can be included for consideration.

Councilor Ellen Robertson asked Human Services DCAO Reginald Gordon to contact LiUNA to ensure the company's participation in future economic development projects.

President Chris Hilbert expressed his support of the introduction of legislation to ensure minority participation in economic development projects.

City Attorney Allen Jackson clarified that **ORD. 2018-257** includes language which would require prior approval by Council for all Council agency employment agreements.

Opposition

Omari Al-Qadaffi spoke in opposition of **RES. 2018-R093** stating that the proposed multifamily residential rental housing project does not align with the affordable housing needs of the city. Mr. Al-Qadaffi asked City Council to exercise more oversight of the Richmond Redevelopment and Housing Authority (RRHA) to ensure its compliance with federal requirements.

Arthur Burton spoke in opposition of RES. 2018-R093 stating that the city has failed to address residents' concerns regarding the leadership for RRHA, and the proposed rental housing project will not benefit the city's minority business owners and residents of the low income neighborhoods.

Councilor Ellen Robertson explained that the proposed multifamily residential rental housing project, as described in **RES. 2018-R093**, will be 100 percent affordable housing units.

There were no further comments or discussions and **the Consent Agenda was unanimously** adopted.

REGULAR AGENDA

The following ordinance was considered:

ORD. 2018-235

To amend and reordain City Code § 26-355, concerning the levy of tax on real estate, to establish a tax rate of \$1.20 for the tax year beginning Jan. 1, 2019, pursuant to Va. Code § 58.1-3321(b), and increasing such rate from the Rolled Back Tax Rate of \$1.129 as computed in accordance with Va. Code § 58.1-3321(a).

President Chris Hilbert provided an overview of the proposed ordinance.

There were no further comments or discussions and **ORD. 2018-235 was adopted:** Ayes 8, Robertson, Larson, Agelasto, Gray, Trammell, Addison, Newbille, Hilbert. Noes None. Jones excused.

The following ordinance was considered:

ORD. 2018-263

To provide for the granting by the City of Richmond to the person, firm or corporation to be ascertained in the manner prescribed by law of certain easements upon, over, under, and across certain property located in the athletic field adjacent to the Hickory Hill Community Center at 3000 East Belt Boulevard for the relocation of communication lines and associated appurtenances in accordance with a certain Deed of Easement.

President Hilbert read a summary of the bid offer for ORD. 2018-263 from Virginia Verizon, LLC.

Chris Frelke, director for the Department of Parks, Recreation and Community Facilities, stated that city administration supports the bid.

There were no further comments or discussions and Councilor Kim Gray moved to accept Virginia Verizon LLC's bid and to adopt ORD. 2018-263, which was seconded and unanimously approved.

The following ordinance was considered:

ORD. 2018-271

To repeal City Code § 26-892, concerning installment payments for certain license taxes, for the purpose of eliminating the option to pay such license taxes in installments.

John Wack, Finance director, explained the intent of ORD. 2018-271.

Lenora Reid, deputy chief administrative officer of Finance and Administration, explained the challenges and administrative costs associated with the installation payment option.

Councilor Kim Gray and Councilwoman Trammell expressed concern about the lack of notification and the financial impact the proposed ordinance could have on businesses throughout the city and asked that ORD. 2018-271 be continued to allow for proper notification.

Ms. Reid agreed to launch an educational campaign to solicit feedback from business owners regarding the change to the payment option.

Councilor Parker Agelasto expressed support of ORD. 2018-271 stating that eliminating the installation payment option will reduce city resources and improve the collection of tax revenue.

Chief Administrative Officer Selena Cuffee-Glenn was present to respond to questions.

Councilor Ellen Robertson and Councilor Kristen Larson stressed the need for city administration to aggressively inform business owners of the new change.

Councilor Kim Gray moved that ORD. 2018-271 be continued to the Monday, December 10, 2018 Council meeting, which was seconded and failed: Ayes 3, Gray, Trammell, Hilbert. Noes 6, Jones, Robertson, Larson, Agelasto, Addison, Newbille.

Opposition

Jennifer Elmore spoke in opposition of ORD. 2018-271 stating that eliminating the installation payment option will financially impact small businesses.

President Chris Hilbert stated that he will not support ORD. 2018-271 because business owners were not properly informed of the proposed change.

There were no further comments or discussions and **ORD. 2018-271 was adopted:** Ayes 6, Jones, Robertson, Larson, Agelasto, Addison, Newbille. Noes 3, Gray, Trammell, Hilbert.

Councilor Ellen Robertson explained the intent of RES. 2018-R094.

Chief Administrative Officer Selena Cuffee-Glenn stated that city administration supports RES. 2018-R094.

It was the consensus of Council that all members be added as co-patrons of RES. 2018-R094.

President Chris Hilbert and Councilor Kim Gray expressed their support of RES 2018-R094.

Councilor Kristen Larson as for clarification on the intent of the proposed legislation.
