PURPOSE: To authorize the Chief Administrative Officer to enter into an agreement with the Virginia Department of Transportation ("VDOT") concerning sanitary sewer utility improvements associated with a project to improve the roadway off ramp of I-95 S.B. near the intersection of 15th Street and Franklin Street.

REASON: Pursuant to VDOT policy on utility relocations for State funded projects, the Project affects existing combined sanitary sewer facilities located within the roadway. The State is responsible for 100% of utility improvement costs associated with the Project.

RECOMMENDATION: Department of Public Utilities recommends adoption of the proposed Ordinance.

BACKGROUND: VDOT is planning a roadway improvement project on the off ramp of I-95 S.B. near the intersection of 15th St. and Franklin St. The roadway improvements will require the replacement of an existing combined sewer inlet, manhole and associated piping located along

AGREEMENT between CITY OF RICHMOND

and

COMMONWEALTH OF VIRGINIA, DEPARTMENT OF TRANSPORTATION for ADJUSTMENT OF WATER and SANITARY SEWER FACILITIES

THIS AGREEMENT, made and entered into as of the _____ day of ____, 2018, by and between the CITY OF RICHMOND (hereinafter called MUNICIPALITY), and the COMMONWEALTH OF VIRGINIA, DEPARTMENT OF TRANSPORTATION, (hereinafter called the STATE), acting by its Commissioner:

WITNESSETH

WHEREAS, the STATE is proposing to construct a section of highway designated as, Franklin Street off Ramp, Project: 0095-127-857, C-501(UPC#107795), which will necessitate changes in the MUNICIPALITY'S water and sanitary sewer facilities: and,

WHEREAS, the STATE and MUNICIPALITY wish to agree upon the terms and conditions under which the necessary changes will be made as hereinafter set forth:

NOW THEREFORE, for and in consideration of the premises and of the mutual covenants herein contained, the parties hereto agree as follows:

SECTION I

- (a) It will be to the best interest of the STATE and the MUNICIPALITY to have the adjustment of the water and sanitary sewer facilities included in the highway contract to be adjusted by the highway contractor.
- (b) The STATE through its highway contractor, will relocate and adjust the MUNICIPALITY'S water and sanitary sewer facilities in accordance with attached plans and the STATE'S Road and Bridge Specifications; said plans being identified as Four (4) one-half size plans sheets numbered 4(1) through 4(4) of the STATE'S construction plans for Project: 0095-127-857, C-501, as attached.

SECTION II

- (a) It has been determined that the project is responsible for bearing 100% of the cost of the water adjustments indicated in SECTION I (b).
- (b) It has been determined that the MUNICIPALITY is responsible for bearing 0.0% of the project cost of the water adjustments.
- (c) It has been determined that the project is responsible for bearing 100% of the cost of the sanitary sewer adjustments indicated in SECTION I (b).
- (d) It has been determined that the MUNICIPALITY is responsible for bearing 0.0% of the project cost of the sanitary sewer adjustments.

SECTION III

In the event, at any time hereafter that the water and sanitary sewer facilities indicated in SECTION I (b) be altered, rebuilt or relocated due to highway construction, the applicable cost incurred by the MUNICIPALITY in connection with such alteration, rebuilding or relocation of its facilities will be paid in accordance with the prevailing laws or rules and regulations in effect at the time the work is performed.

SECTION IV

The MUNICIPALITY agrees that the existing facilities, which are to be abandoned, will become the property of the STATE's highway contractor with exceptions as noted in the attached plans. Any salvage value derived therefrom will accrue to the STATE'S highway contractor.






