President Cynthia Newbille called the meeting to order at 6:00 p.m., and presided.

Invocation was offered by Reverend Benjamin Campbell, St Paul's Episcopal Church, 815 East Grace Street, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

CHAMBER EMERGENCY EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

Upon the President's request, Interim Deputy City Clerk Lisa Braxton provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

Councilor Parker Agelasto recognized the Virginia Home on its 125th anniversary and thanked the Virginia Home Board of Trustees and the devoted staff for their dedication and care.

CITIZEN COMMENT

Deborah Driver urged residents to be actively involved in the Black Lives Matter movement even when it involves black on black homicides.

Michael Brown addressed Council regarding residency requirements for members of City Council and urged Council to take action to enforce the requirements.

AGENDA REVIEW AND AMENDMENTS

Councilor Ellen Robertson moved to amend the agenda as follows:

Councilor Kristen Larson expressed support for ORD. 2018-322.

REGULAR AGENDA

The following ordinance was considered:

ORD. 2018-304

To amend and reordain Ord. No. 75-309-302, adopted Dec. 15, 1975, as most recently amended by Ord. No. 2017-227, adopted Dec. 11, 2017, pertaining to the "Stony Point Community Unit Plan," for the purpose of amending the development standards, as they pertain to Map Section K of the Southern Portion of the Plan, to allow for residential development.

Support

Jeff Geiger, Hirschler Law partner and applicant representative, spoke in support of ORD. 2018-304 stating that the townhouse development will increase the inventory of affordable homes in the area and the project conforms to the recommendations of the City's Master Plan. Mr. Geiger further stated that the developer made modifications to address concerns expressed by the community and the project will bring new economic support for the neighborhood shopping center.

Opposition

Elizabeth Diggens spoke in opposition of ORD. 2018-304 stating that the proposed development was not compatible with the surrounding community, it will devalue existing properties, and infringe upon the privacy of the single-family homes that abut the development. Ms. Diggens further stated that the property should be maintained for church use.

Nancy Persinger spoke in opposition of ORD. 2018-304 stating that the property should be maintained as a wooded area.

Dottie Riley spoke in opposition of ORD. 2018-304 stating that a majority of the residence in the Summer Hill Senior Housing development opposes the proposed development and the property should remain undeveloped.

Jay Romero spoke in opposition of ORD. 2018-304 stating that area residents did not support the proposed development and developing the property will disturb the wildlife located in the area.

Councilor Kristen Larson thanked citizens for their comments and clarified that the parcel was designated for church use; however, a church was never constructed. Ms. Larson stated that the developer did a good job holding community meetings, listening to the feedback provided and modifying their plans based on that feedback. Councilor Larson further stated that the proposed development was compatible with other uses allowed in the community unit plan and will provide diversity in housing stock in the area.

It was the consensus of Council to suspend Council's Rules of Procedure to reopen the public hearing for one speaker.

Opposition

Jim Parker spoke in opposition of ORD. 2018-304 and provided an aerial map of the neighborhood. Mr. Parker expressed concerns regarding the density and a lack of a buffer from adjacent residential uses.

A copy of the information provided has been filed.

Councilwoman Reva Trammell expressed concerns from an adjacent resident and asked that ORD. 2018-304 to be continued to allow time to address concerns from neighbors.

Councilor Larson stated that she was comfortable with the proposed development and would like Council to continue its consideration.

Councilor Ellen Robertson expressed support of the proposed development and remarked that the City Planning Commission approved the project and the developer modified aspects of the proposal to address the concerns of the neighborhood.

Mr. Geiger responded to questions regarding the selling price for the proposed units.

There were no further comments or discussions and **ORD. 2018-304 was adopted:** Ayes 7, Jones, Robertson, Larson, Agelasto, Gray, Addison, Newbille. Noes 1, Trammell.

Sec. 24-133. Increasing the number of permitted shared mobility devices.

(a) On a quarterly basis from the date of the issuance of a permit issued in accordance with this division and upon payment of the annual fee set forth in Appendix A to this Code for each additional shared mobility device permitted by this section, any permittee may submit a written request to the Director to increase the maximum number of shared mobility devices covered by such permittee's permit issued in accordance with this division. Upon receipt of such request and payment of the fee set forth in Appendix A to this Code, the Director shall consider such request in accordance with the requirements of this section. Within 30 days from the date of the receipt of such request, the Director shall increase the maximum number of shared mobility devices covered by such permit by an amount equal to 25 percent of the maximum number of shared mobility devices covered by such permit on the date of issuance of such permit if the permittee, along with such written request, provides the Director with such evidence as the Director may lawfully require demonstrating that the following conditions have been met:

- (1) The shared mobility devices covered by a permit issued in accordance with this division have been operated on an average of three or more trips per day, which trips may begin or end in the city, either or both, for each day of the applicable quarterly period covered by the permit.
- (2) The permittee has complied with all of the requirements of (i) the permit for which an increase in the maximum number of shared mobility devices has been requested, (ii) this division, and (iii) all applicable state, federal, and local laws.
- (b) The number of shared mobility devices covered by any permit issued in accordance with this division may only be increased as provided in this section. Notwithstanding any provision of this division to the contrary, the Director, upon application therefor by the permittee, shall issue to a permittee a renewal permit or reinstated permit covering a number of shared mobility devices that is equal to the total number of shared mobility devices permitted on the date of the expiration of such permittee's immediately preceding permit for which the number of shared mobility devices was increased one or more times in accordance with this section, provided that such preceding permit expired no more than 30 days prior to the filing of an application for a renewal permit or reinstated permit.
- (c) Any application to renew a permittee's permit for which the maximum number of shared mobility devices permitted resulted from one or more increases made by the Director in accordance with this section shall be filed in accordance with the requirements of this division. In addition, such application shall be accompanied by the payment of the annual fee set forth in Appendix A to this Code for each additional shared mobility device covered by an increase made by the Director during all preceding permit periods in accordance with this section and shall be filed no later than 30 days after the expiration date of the immediately preceding permit for which an increase was made by the Director.
- (d) Any application to reinstate a permittee's permit for which the maximum number of shared mobility devices permitted resulted from one or more increases made by the Director in accordance with this section shall be filed in accordance with the requirements of this division. In addition, such application shall be accompanied by the payment of the annual fee set forth in Appendix A to this Code for each additional shared mobility device covered by an increase made the Director during all preceding permit periods in accordance with this section and shall be filed no later than 30 days after the expiration date of the immediately preceding permit for which an increase was made by the Director.
- (e) For any permit, renewal permit, or reinstated permit, the maximum number of shared mobility devices of which resulted from one or more increases made by the Director in accordance with this section, the Director shall reduce the fee set forth in Appendix A to this Code according to the number of days, if any, within the applicable permit period that each additional shared mobility device permitted in accordance with this section was not covered by a permit issued in accordance with this division. In the alternative, any permittee may file an application to obtain a new permit in accordance with the requirements of this division.
