CIP Methodology

The FY2020 – 2024 Capital Improvement Plan focuses on:

- Neighborhoods/Streets
- Schools
- Addressing Life/Health/Safety issues and concerns
- Minimal adjustments to the planned years
- Projects to be completed

CIP Revenues

- FY20 Planned Funding Sources: \$36,364,454
- FY20 Proposed Funding Sources:\$96,935,236

• More Debt Capacity (GO Bonds, Federal/State Revenue, and Cash)

FY2020-FY2024 Capital Budget Highlights

- Funds \$15M in Paving and \$1.2M in Sidewalk Projects
- Funds 100% of Richmond Public Schools (RPS) request for eligible projects (\$19M in FY20)

• Provides funding for Recreational Facilities and Parks

• Provides Cash towards projects, a financial best practice


- Provides \$3M for Fire Apparatus (in Fleet Services)
- Provides for three ADA projects to make the City more inclusive
 - (Universal Access to James River; Access to Brown's Island from Tredegar St.; Canal Walk Connector to Brown's island)
- Provides \$200M to RPS in FY2024 for Schools Modernization

Capital Improvement Plan


- The City is providing a Long Range Capital Improvement Plan with the Proposed Fiscal Years 2020 through 2024 CIP.
- This 20-year long range CIP will focus on investing in the City's physical infrastructure to include maintaining basic services and strategic investments needed to increase economic empowerment; provide for vibrant, inclusive and mobile neighborhoods; and address issues of public safety, health and wellness.
- This plan, the first in the City's history, takes the needs of the City, organizes them, and shows a funding plan for those needs.



Appropriations by Category: FY20 – F24 (General Fund Capital)




City of Richmond, Virginia - Proposed Capital Improvement Plan, Fiscal Years 2020-2024




Appropriations by Category: FY20 (Non-General Fund Capital)




