2020 General Assembly (GA) Legislative Schedule

Joyce Davis, Council policy analyst, provided councilors with the 2020 GA legislative schedule and noted the inclusion of two deadline dates, June 28, 2019 and August 15, 2019, for submission of their individual ideas to the city's legislative agenda proposal, in an effort to improve Council's legislative submission process. A copy of the information provided has been filed.

Docket Review

Revisiting a docket review item, Mark Olinger, Planning and Development Review director, informed Council that the proposed adoption of Res. 2018-R092 would demand an additional level of review by the City Attorney's Office for certificates of zoning compliance and letters of zoning confirmation, which would prolong current streamlined processes.

President Cynthia Newbille asked councilors to consider a continuance of Res. 2018-R092 since the patron was unavailable to address concerns regarding the proposed legislation.

Councilor Kim Gray, citing uncertainty with the suggested adoption, voiced opposition of Res. 2018-R092 and requested that the proposed legislation not be continued, and instead be considered later that evening at the Formal Session of Council.
