# **REGULAR AGENDA**

# The following ordinance was considered:

# ORD. 2019-125

To amend Ord. No. 2018-057, adopted May 14, 2018, which adopted the Fiscal Year 2018-2019 General Fund Budget and made appropriations pursuant thereto, by increasing the amount of funds available for appropriation by \$8,519,814.00 from various sources, transferring funds from various agencies and non-departmental programs, and appropriated the additional funds available for appropriation and the transferred funds to various agencies and non-departmental programs.

Budget and Strategic Planning Director Jay Brown introduced ORD. 2019-125 and explained the proposed ordinance will amend the FY 2019 General Fund Budget by re-allocating funds between agencies, increase the total general fund to meet projected obligations and appropriate funds from the Assigned Fund Balance and the Budget and Revenue Stabilization Contingency Reserve. Mr. Brown further explained that the use of the Budget and Revenue Stabilization Contingency Reserve may not be required if there are changes to the revenue projections and agency spending.

Finance Director John Wack was present to respond to questions.

Councilor Parker Agelasto stated that ORD. 2019-125 should not be considered by City Council until concerns expressed during the May 16<sup>th</sup> Finance and Economic Development Standing Committee meeting were addressed. Councilor Agelasto expressed frustration that bundling of multiple actions into the same ordinance limited Council's ability to consider items separately; he stated that he will not support the use of the Budget and Revenue Stabilization Contingency and Reserve to cover preliminary shortfalls.

Senior Assistant City Attorney Tabrica Rentz provided Council with responses to questions asked during the Informal Meeting of Council.

Councilor Kim Gray expressed concern that the proposed ordinance did not accurately identify which City Attorney's office special fund would receive an appropriation, and she would like assurances that the funds would in fact be appropriated to the intended department.

Councilwoman Reva Trammell questioned the impact the budget appropriation decreases will have on the operation of departments, and the additional spending by various departments. Councilwoman Trammell stated that she would like an explanation from the City Auditor regarding the appropriation process.

President Cynthia Newbille asked City Auditor Lou Lassiter to provide a response to concerns expressed by Ms. Trammell.

Lou Lassiter provided an overview of the budget process for his department, and reported that his department plans to submit next year's audit plan to review the departments with large budget variances.

Councilor Kristen Larson expressed concerns that the proposed ordinance did not clearly identify which special fund will receive an appropriation and questioned the use of the Budget and Revenue Stabilization Contingency Reserve.

Vice President Chris Hilbert stated that he was disappointed in city administration's failure to accurately identify the special fund category for the appropriation and its lack of communication with Council regarding budgetary needs.

Councilor Agelasto remarked that the ORD. 2019-125 should be amended to include actual revenues and expenditures.

Councilor Kim Gray moved that ORD. 2019-125 be continued to the Monday, June 10, 2019 Council meeting or a special meeting of Council, which was seconded and failed: Ayes 4, Larson, Agelasto, Gray, Trammell. Noes 5, Jones Robertson, Addison, Hilbert, Newbille.

Councilor Michael Jones moved that ORD. 2019-125 be adopted, which was seconded and approved: Ayes 6, Jones, Robertson, Trammell, Addison, Hilbert, Newbille. Noes 3, Larson, Agelasto, Gray.

President Cynthia Newbille remarked that it is the expectation of City Council for city administration to address its concerns regarding the timeline for the submission of budget appropriation requests, the budget appropriation process and budget briefings with Council, at a future Finance and Economic Development Standing Committee Meeting.

Councilor Parker Agelasto stated there needs to be a full analysis of the current budgeting system to ensure city departments are operating within the budget approved by City Council.
