By virtue of the authority vested in the United States of America, Commonwealth of Virginia, Virginia Code of Laws and the Richmond City Charter: the Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, does hereby officially proclaim:

Maggie L. Walker Day

Whereas, The Honorable Members of the Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to once again officially commemorate, honor and celebrate the historic life, work, importance, and legacy of Mrs. Maggie Lena Draper Mitchell Walker (July 15, 1864 - December 15, 1934); and

Whereas, Born in Richmond, Virginia on July 15, 1864, Mrs. Maggie Lena Walker was as a celebrated civic leader, teacher, banker, social activist, humanitarian, and entrepreneur; and

Whereas, Throughout her life, Mrs. Walker broke color and gender barriers of her time in creating and promoting social, racial, gender, and economic success on behalf of people of African American descent, especially for women and children; and

Whereas, Dedicated to community service, Mrs. Walker served critical roles in supporting, creating, and providing leadership for numerous civic organizations during the late nineteenth century and early twentieth century, which included establishing the Juvenile Branch of the Independent Order of St. Luke, an African American fraternal society; and, co-founding the Richmond Chapter of the National Association for the Advancement of Colored People, and the Council of Colored Women; and

Whereas, As further testament to her intellect, leadership, and fortitude, Mrs. Walker founded the St. Luke Emporium, a department store located on 112 E. Broad Street in Richmond, Virginia and was the first known woman of African American descent to establish and be president of a bank (St. Luke Penny Savings Bank in Richmond) in the United States of America; and

Whereas, In recognition of her significant accomplishments, success, and contributions, not only on behalf of Richmond but to the history of the United States of America, Mrs. Walker's former home, located on Leigh Street in Richmond's Jackson Ward Neighborhood, was designated as a National Historic Site and is managed and maintained by the U.S. Department of the Interior National Park Service; and

Whereas, In 2013 Richmond City Council officially proclaimed Mrs. Walker's birthday, July 15, to be Maggie L. Walker Day in Richmond, Virginia and has established it in perpetuity; and

Whereas, In further recognition of the immense significance of her historical importance, Richmond established the massively impressive Maggie L. Walker Public Art Project Statue and Plaza at Adams and Broad Streets, which was unveiled on July 15, 2017 in Richmond, Virginia;

Now, Therefore, In order to further recognize, honor, and celebrate the historic life, work, importance, and legacy of Mrs. Maggie Lena Draper Mitchell Walker, the Richmond City Council does hereby once again re-proclaim her birthday, July 15, in perpetuity as Maggie L.
