BACKGROUND

Traffic calming studies were conducted in the Stoney Point area along the Evansway Lane/Cedar Grove Road/Croatan Road corridor. As a result of the studies, the City's Traffic Engineering Division has conducted such studies and found that the speed and volume justified enhanced penalties for speeding along the Evansway Lane/Cedar Grove

Road/Croatan Road corridor. The study found that vehicles frequently travel above the posted speed limit of 25 mph in the area. Signage is necessary to reflect the enhanced penalty.

I am requesting that the Department of Public Works install "Speeding \$200 Additional Fine" signage on the Evansway Lane/Cedar Grove Road/Croatan Road corridor between Whitehorse Road and Cherokee Road. The vehicular speeds in this area were studied as part of the Huguenot Neighborhood Traffic Calming Study. The 85th percentile speed averaged 35 mph in the posted 25 mph zone, warranting enhanced speeding penalty signs.
