President Cynthia Newbille called the meeting to order at 6:01 p.m., and presided.

Invocation was offered by Reverend Clifford B. Chambliss, Jr. of Garland Avenue Baptist Church, 2700 Garland Avenue, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

CHAMBER EMERGENCY EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

Councilwoman Reva Trammell, on behalf of Richmond City Council, recognized the Department of Emergency Communications for its service to the community and receiving Public Safety Communications Accreditation status from the Commission on Accreditation for Law Enforcement Agencies, Inc.

Councilor Andreas Addison, on behalf of Richmond City Council, recognized the Richmond Public Schools Thomas Jefferson High School Robotics Team for their imagination, determination and hard work while competing in the international level 2019 FIRST Robotics Championship.

Councilor Kim Gray, on behalf of Richmond City Council, recognized and celebrated the historic life, work and legacy of Mrs. Maggie Lena Draper Mitchell Walker and re-proclaimed her birthday, July 15, as Maggie L. Walker Day.

CITIZEN COMMENT

Melvin Jones spoke about recent crime and gun violence within the city. In addition, Mr. Jones addressed the denial of his application for real estate tax relief for the elderly.

Council President Cynthia Newbille asked that John Wack, Department of Finance director, speak with Mr. Jones after the conclusion of his comments.

Viola Baskerville thanked Council for its efforts in renaming Arthur Ashe Boulevard and asked for Council's support in the restoration of Historic Evergreen Cemetery.

Councilor Kim Gray stated Council needed to have a future discussion regarding parking for individuals with a disability as it relates to Ord. 2018-233.

Opposition

John Wack, Finance Department director, spoke in opposition to Ord. 2019-158 stating this ordinance would run counter to the city's current fund balance policy, as it would prevent the

replenishment of "rainy-day" fund accounts.

Roland M. Kooch, Jr., Davenport & Co. senior vice president, and financial advisor to the city, spoke in opposition to Ord. 2019-158 and stated it would conflict with the city's fund balance policy of distributing surplus balances to "rainy-day" funds and the revenue stabilization fund. He informed Council the policy is viewed favorably by credit rating agencies.

Tyrell Robertson, spoke in opposition to Ord. 2019-141 stating the proposed amendment to remove the off-street parking requirement for the property located at 410 Hancock Street would lead to highly contested parking on the 400 block of Hancock Street.

Councilor Kim Gray informed Mr. Robertson that the property owner tried to remain in compliance with the original ordinance, but was unable to purchase and secure off-street parking due to increased development.

Hugh Edmonds, spoke in opposition to Ord. 2019-141 and stated he may have a partial solution to the parking issue and wanted to speak with Councilor Gray after his public comment. He emphasized the difficulty of parking on the 400 block of Hancock Street.

Support

Lory Markham, representing the 410 Hancock Street property owner, spoke in support of Ord. 2019-141 and stated the property owner would be willing to work with residents in efforts to find solutions to parking on Hancock Street.

Sally Wetzler, **James River Outdoor Coalition board member and treasurer**, spoke in support of Ord. 2019-158, specifically for the James River accessibility improvements for people with disabilities, the ordinance would create.

Councilor Kristen Larson thanked Ms. Wetzler and asked for Council's support regarding Ord. 2019-158.

Councilor Michael Jones questioned if a resolution addressing the matter might be a better solution than an ordinance.

Councilor Ellen Robertson voiced concern about an ordinance regarding capital project funding, but offered support of a resolution addressing the issue and offered to co-patron such legislation.

There were no further comments or discussions and the **Consent Agenda was unanimously adopted with the exception of ORDS. 2019-144 and 2019-145, which were also adopted:** Ayes 8, Jones, Robertson, Larson, Agelasto, Gray, Trammell, Addison, Newbille. President Cynthia Newbille read a summary of the bid offer for ORD. 2019-130 from Lumos Networks, Inc., doing business as Segra.

There were no further comments or discussions and Councilor Ellen Robertson moved to accept Lumos Networks, Inc.'s bid and to adopt ORD. 2019-130, which was seconded and unanimously approved.

To amend Ord. No. 2018-057, adopted May 14, 2018, which adopted the Fiscal Year 2018-2019 General Fund Budget and made appropriations pursuant thereto, by transferring funds in the amount of \$30,000.00 from the Office of Community Wealth Building's Workforce Development program and re-appropriating these transferred funds to a new line item in the Non-Departmental agency called the "Owens & Minor Medical, Inc. On the Job Training Grant through the EDA" line item for the purpose of making a grant to Owens & Minor Medical, Inc., to subsidize certain job training activities by Owens & Minor Medical, Inc.

ORD. 2019-152

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute a Workforce Development Grant Performance Agreement between the City of Richmond, Owens & Minor Medical, Inc., and the Economic Development Authority of the City of Richmond, Virginia, for the purpose of providing Owens & Minor, Medical, Inc., with incentives to assist Owens & Minor Medical, Inc., with the hiring and workforce development for the employees at the customer engagement center in the city of Richmond.

Jane Ferrara, Department of Economic Development deputy director, and Valaryee Mitchell, Office of Community Wealth Building director, introduced the proposed ordinances.

Councilor Parker Agelasto, noted he raised questions regarding the proposed ordinances at the June 20, 2019 Finance & Economic Development Standing Committee meeting, but had yet to receive any answers. He stated that he specifically requested information on the number of city residents who received employment through the program.

Ms. Mitchell stated 153 city residents received employment through the program. There were no further comments or discussions and **ORDS. 2018-254 and 2019-152 were unanimously adopted.**

ORD. 2019-153

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute an Assignment and Assumption of License Agreements between the City of Richmond and the Richmond Metropolitan Transportation Authority for the purpose of transferring license agreements for certain events held at Main Street Station from the Richmond Metropolitan Transportation Authority to the City.

ORD. 2019-154

To amend ch. 8 of the City Code by adding therein a new art. XIII, consisting of § 8-545, concerning the establishment of fees for licenses to temporarily use Main Street Station or portions thereof, and to amend Appendix A of the City Code by adding therein new fees for § 8-545, for the purpose of establishing a schedule of fees for the temporary use of Main Street Station.

Lynne Lancaster, Department of Public Works, Parking & Shared Mobility deputy director, introduced the proposed ordinances.

Councilor Parker Agelasto inquired about the fee structure for space rental of Main Street Station.

Leonard Sledge, Economic Development director, informed Council that the fee structure will increase rental fees 3% each year until the year 2021. Mr. Sledge provided additional fiscal data regarding revenue generated by the station.

Mr. Agelasto asked if revenue collected from contracts initiated prior to the transfer of license agreements for Main Street Station would be received by the city, and if so, would a budget amendment be required to receive those funds.

Ms. Lancaster stated the funds would be transferred, but that she is unsure about any required amendments.

Jay Brown, Budget and Strategic Planning director, informed Council that a budget amendment will be required if revenue exceeds the allocated fund balance for the Department of Public Works.

There were no further comments or discussions and **ORDS. 2019-153 and 2019-154 were adopted:** Ayes 8, Jones, Robertson, Larson, Gray, Trammell, Addison, Hilbert, Newbille. Noes 1, Agelasto.

President Cynthia Newbille informed Council the resolution does not prohibit gun possession from members of the public in City Hall.

Councilor Kim Gray discussed the unknown costs associated with installation and use of metal detectors.

Councilor Parker Agelasto inquired whether the resolution could be referred to the June 25, 2019 Public Safety Standing Committee meeting for review instead of being expedited.

Councilor Jones stated he had no issue with the resolution being referred to the Public Safety Standing Committee.

Councilor Michael Jones moved to refer RES. 2019-R022 to the June 25, 2019 Public Safety Standing Committee meeting for recommendation, and to continue the proposed resolution to the July 22, 2019 Council Meeting, which was seconded and approved: Ayes 8, Jones, Robertson, Larson, Agelasto, Gray, Trammell, Addison, Newbille.
