That, pursuant to section 2.03(a) of the Charter of the City of Richmond (2019), as amended, pedestrian curb ramps shall be installed on the northwest, southwest, and southeast corners at the intersection of Juniper Street and 3rd Avenue, and on the northwest, southwest, northeast, and southeast corners at the intersection of Spruce Street and 3rd Avenue.

§ 2. This ordinance shall be in force and effect upon adoption.

ORDINANCE/RESOLUTION SUMMARY

 The Patron requests an ordinance to require installation of handicap access curbs at all four corners of the intersections of Spruce St. and 3rd Avenue, and Juniper Street and 3rd Avenue.

BACKGROUND

Summary:

- The intersections of Spruce St. and 3rd Avenue, and Juniper Street and 3rd Avenue are located at each end of the 2300 block of 3rd Avenue.
- The patron believes that the installation of handicap access curbs will lessen the dangers to users, and improve safety and accessibility for the public.
- Ordinance No. 2018-311, adopted by City Council on January 28, 2019, addressed the installation of Stop signs and one handicap access curb at Juniper Street and 3rd Avenue. This request provides for handicapped access curbs at all four corners at the intersection of Juniper and 3rd Avenue.
