Councilwoman Reva Trammell requested information about liability insurance for volunteers with regard to the proposed exemption from grass cutting statutes for certain persons.

Councilor Gray asked that items that do not require state action be assigned to a separate list.

Councilor Addison requested information concerning the fiscal impact of an electronic voting system.
