President Cynthia Newbille called the meeting to order at 6:03 p.m., and presided.

Invocation was offered by Deacon Francis Nelson of Holy Rosary Catholic Church, 3300 R Street, Richmond, VA 23223, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

CHAMBER EMERGENCY EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

Richmond City Council recognized the visiting delegation from the City of Ségou, Republic of Mali, and celebrated the 10-year anniversary of Ségou's Sister City relationship with the city of Richmond. Councilmembers thanked the city of Ségou's delegation for their service, leadership and dedication on behalf of their community.

CITIZEN COMMENT

Erika Misseri addressed Council and proposed that festivals and other public events held within the city be required to provide recycling receptacles.

Barbara Starkey-Goode addressed Council and expressed her concern with speed limit violations on Gordon Avenue. Ms. Starkey-Goode stated she believed a lack of speed limit enforcement was the main contributing factor to vehicles speeding on Gordon Avenue. Ms. Starkey-Goode requested speed tables be placed on Gordon Avenue to reduce speeding.

Councilwoman Reva Trammell thanked Ms. Starkey-Goode for her comments and expressed her support for speed tables to be placed on Gordon Avenue.

Councilor Andreas Addison addressed the issue of speed violations throughout the city. He stated he was working with additional councilmembers and city administration on Vision Zero proposals and policy recommendations that will address street safety.

Dominique Crutchfield expressed his support for the proposed Navy Hill Development Project. He stated the proposed project would provide Richmond Public Schools with additional funding for students and potential jobs for graduating students.

William Spencer addressed Council and requested the city declare a climate emergency due to global warming. Mr. Spencer expressed his concern that proposed plans to reduce emission levels by 80% by the year 2050 did not sufficiently address global warming.

A copy of the material provided has been filed.

Robert Winfree, New Life Deliverance Tabernacle pastor, expressed his support for the proposed Navy Hill Development Project. Pastor Winfree stated the proposed project would provide job opportunities and referenced the project's job training programs. He also stated the project and proposed coliseum would bring positive attention and added entertainment to the city.

Councilor Michael Jones thanked Pastor Winfree for his comments and commended his efforts on improving the lives of city residents through his work as a pastor of New Life Deliverance Tabernacle.

Opposition

Mia Mimms, Mimms Funeral Home funeral director, addressed Council regarding Ord. 2019-257. Ms. Mimms expressed her concerns with the proposed rezoning and lack of public notice of the ordinance. She also stated the ordinance would allow buildings up to 12 stories and stated any potential 12-story building would not match characteristics of the neighborhood. She asked consideration of the ordinance be continued to allow more discussion within the neighborhood.

Bennette Burks addressed Council regarding Ord. 2019-259, and stated he was speaking on behalf of several neighbors located near 214 N. Lombardy Street. Mr. Burks informed Council he believed the property was not suitable for the proposed modifications identified in the proposed ordinance. He requested three changes be made to the ordinance, which included a five-year moratorium on the sale of alcohol at the property, all trash be screened on the premises, and live musical performances be prohibited.

Support

Greg Lucyk, One Virginia 2021 advocacy board member, spoke in support of Res. 2019-R052, and informed Council of the United States Supreme Court's *Rucho v. Common Cause* opinion issued June 27, 2019, on the subject of gerrymandering. Mr. Lucyk stated because of the U.S. Supreme Court's decision, the proposed resolution was necessary. Mr. Lucyk provided information regarding proposed anti-gerrymandering legislation pending with the General Assembly of Virginia.

Preston Lloyd, Williams Mullen partner, representing the 214 N. Lombardy Street applicant, spoke in support of Ord. 2019-259. Mr. Lloyd addressed the issues raised by Bennette Burks and stated regulations were in place to alleviate his concerns.

Councilor Kim Gray expressed her support for Ord. 2019-259 and stated the special use permit addressed the concerns Mr. Burks raised.

Councilor Parker Agelasto thanked Mia Mimms for her comments and requested Council consider continuing Ord. 2019-257 to provide more time for additional conversations regarding the proposed ordinance.

Councilwoman Reva Trammell indicated she spoke with nearby business owners also concerned about the impact of Ord. 2019-257, and expressed her support for the requested continuance.

Councilor Parker Agelasto moved to continue ORD. 2019-257 to the Tuesday, November 12, 2019, City Council meeting, which was seconded and unanimously approved.

There were no further comments or discussions and the **Consent Agenda was unanimously** adopted, with the exception of ORD. 2019-257.

Councilor Kristen Larson moved to expedite consideration of the following resolution, which was seconded and considered:

Councilor Kim Gray expressed her concern about the lack of notice for a public hearing regarding expedited Richmond Redevelopment Housing Authority (RRHA) legislation. Councilor Gray inquired if expedited consideration was necessary.

Michael W. Graff, Jr., RRHA bond counsel, informed Council expedited consideration was necessary to allow the applicant enough time to obtain the revenue bond allocation. Mr. Graff stated RRHA and developers were aware that expedited consideration of legislation should be requested only when necessary.

Councilor Ellen Robertson informed Council the proposed resolution addressed housing for low-income seniors within the city and believed expedited consideration was necessary. She inquired from Mr. Graff if anyone from the public spoke to the proposal at RRHA public hearings.

Mr. Graff stated someone did speak in opposition to the proposal.

Councilor Gray stated she would vote in favor of expedited consideration due to housing needs for seniors, but stressed the importance of public input regarding legislation considered by Council.

Councilor Parker Agelasto stated he would not support expedited consideration and expressed his concern with the limited information provided by RRHA's submitted summary of public statements. Councilor Agelasto also stated RRHA public hearing advertisements should be placed in free publications to promote greater distribution among citizens.

After additional discussion **the motion to expedite consideration was approved**: Ayes 8, Jones, Robertson, Larson, Gray, Trammell, Addison, Hilbert, Newbille. Noes 1, Agelasto.

There were no further comments or discussions and **RES. 2019-R058 was unanimously adopted.**
