PlanRVA is among 21 planning districts across Virginia that have been chartered regionally by local governments following the creation of a working framework empowered by the Virginia General Assembly - Virginia Area Development Act of 1968, as revised and retitled by the Regional Cooperation Act in 1995.

PlanRVA is governed by a PlanRva Commission, whose membership is drawn from representatives of towns, cities, and counties within its service area, which appoints an Executive Director to provide leadership, direction, and oversight of its 21-member staff and day-to-day operations, which are headquarters at 9211 Forest Hill Avenue #200, in Richmond, Virginia.



### **Richmond Public Schools** Armstrong-Walker Football Classic (December 2, 1938 - November 25, 1978)

Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, does hereby officially and fondly remember, commemorate, and memorialize the Richmond Public Schools Armstrong-Walker Football Classic game, held in Richmond from 1938 to 1978.

Begun serendipitously on December 2, 1938 as a non-season pick-up football scrimmage game between Richmond Public Schools - Armstrong High School and the newly established Richmond Public Schools - Maggie L. Walker High School (less than three months after it opened its doors), the Richmond Public Schools Armstrong-Walker Football Classic, as it would later be know, became a much celebrated, anticipated, heralded, and guintessential annual Richmond tradition for more than four decades.

Graciously hosted in the early years on the campus at Virginia Union University at Hovey Field stadium (which now ranks second only to Harvard University as the oldest college football stadium still in use in the United States), the Armstrong-Walker Football Classic was played each Thanksgiving weekend and, drawing larger and larger crowds, crowned its glorious run on November 25, 1978 in front of a record-breaking audience of 43,000 in Richmond City Stadium.

Marking the end of an historic era, in the late 1970's Richmond Public Schools began consolidating its seven high schools into three combined schools, bringing an end to Richmond Public Schools - Armstrong High School, Richmond Public Schools - Maggie L. Walker High School, their respective Wildcats and Green Dragons football teams, and, lamentably, the historic Armstrong-Walker Football Classic.

Now, Therefore, Richmond City Council does hereby officially and fondly remember, commemorate, and memorialize, in perpetuity, the Richmond Public Schools Armstrong-Walker Football Classic game, held in Richmond from 1938 to 1978, and honors its halcyon memory and the event's directors, planners, managers, team members, supporters, families, school faculty and staff, students, alumni, volunteers, sponsors, and fans throughout the years who made this much-loved annual
