PURPOSE: To authorize the Chief Administrative Officer to accept funds in the amount of \$13,888 from the Virginia Department of Criminal Justice Services and to appropriate these funds to the Department of Justice Services FY 2020 Special Fund Budget for the purpose of 3% salary increases for grant funded employees funded 100% with state grant funds.

REASON: The Department of Justice Services received a grant award notification from the Virginia Department of Criminal Justice Services informing the City of an increase to FY20 funds. The Community Corrections total grant award will be in the amount \$1,163,000. However, the 2019-2020 Special Fund Budget (Ordinance Number 2019-042) adopted on May 13, 2019 lists Community Corrections funds in the amount of \$1,149,112, which is \$13,888 less than the actual award. As a result, acceptance approval of the additional \$13,888 requires action by City Council.

RECOMMENDATION: Adoption of this ordinance.

BACKGROUND: The Governor's FY2020 Budget included the additional funds with the requirement that they were to be used for salary increases. The funds were added to all Local Probation and Pretrial program grant awards by the Department of Criminal Justice Services, of which the City of Richmond Department of Justice Services is included.
