The motion was seconded and unanimously approved.

AWARDS AND PRESENTATIONS

President Cynthia Newbille and Vice President Chris Hilbert, on behalf of Richmond City Council, proclaimed the week before Thanksgiving as Richmond Hunger and Homelessness Awareness week. President Newbille and Vice President Hilbert recognized and thanked dedicated individuals, organizations and entities that have contributed to prevent and respond to hunger and homelessness.

Councilwoman Reva Trammell and Councilor Kim Gray, on behalf of Richmond City Council, recognized and honored Carolyn N. Thomas for her many years of service as an election officer and Chief Election Officer for the Commonwealth of Virginia Richmond Electoral Board. At the request of Councilwoman Trammell, Joe Morrissey, Virginia Senator-elect, 16th Voter District, recited a letter of appreciation of Ms. Thomas and her years of service.

Councilor Parker Agelasto, on behalf of Richmond City Council, recognized the Richmond Little League Intermediate 50/70 All Star Baseball team for their success in winning the Little League Regional District Championship Series and the Regional State Baseball Championship Series, and for the team's participation in the international Regional Baseball Championship Series.

Councilor Parker Agelasto, recognized the Ephesus Seventh-day Adventist Church – Richmond Pathfinders Club – Rams Drumline team for the team's recent competition success and stated the team was not in attendance to receive an award due to a scheduling conflict.

CITIZEN COMMENT

Melvin Jones, Jr. addressed Council and suggested the Greater Richmond Transit Center (GRTC) provide an additional bus route on Laburnum Avenue near Essex Village to alleviate riders' wait time. Mr. Jones also expressed his frustrations with speeding vehicles and drug trafficking on North Avenue.

Councilor Parker Agelasto clarified that the Essex Village community was located in Henrico County, Virginia, and stated collaboration with Henrico County and GRTC was required to address the issue.

Earl Bradley addressed Council and expressed his concerns regarding nepotism and favoritism with awarding of city projects. At Mr. Bradley's request, King Salim Khalfani discussed with members Mr. Bradley's issues with procurement contracts and competitive bidding on city projects.

Emma Clark addressed Council regarding her concerns with public-private partnerships. Ms. Clark questioned the motives behind corporations seeking incentives from the city regarding potential development projects.

Allen Chipman addressed Council regarding recent evictions within Richmond Redevelopment & Housing Authority (RRHA) public housing communities. Mr. Chipman summarized information he received from a Freedom of Information Act request from RRHA regarding evictions and lack of new tenant approvals. Mr. Chipman expressed his concerns that actions taken by RRHA violated United States Department of Housing and Urban Development rules.

A copy of the material provided has been filed.

Nicholas Da Silva addressed Council and informed members of citizens' concerns regarding public housing. Mr. Da Silva expressed his belief that neglect within public housing communities reached the level of an act of violence.

Jasmine Leeward addressed Council and discussed recent evictions within public housing communities. Ms. Leeward informed Council she observed similar issues with evictions and proposed mixed-use projects in Norfolk, Virginia. Ms. Leeward stated eviction prevention should be a high priority of the city.

Charles Taft Peters, Ill, Richmond Democratic Socialists of America communications committee chair, expressed his outrage regarding recent RRHA evictions. Mr. Peters addressed RRHA not renting open units and the lack of public notice regarding RRHA board meetings. Mr. Peters requested Council take action and assert control over RRHA.

Regie Ford addressed Council and discussed the closed Oak Grove Elementary School. Mr. Ford requested an adaptive reuse plan be created for the vacant school. Mr. Ford stated the building was too old to be renovated for school use, but suggested other public uses for the property were possible.

Opposition

Kristin Reed, Citizen Advisory Commission on Alternatives to Incarceration member, expressed her disappointment with Ord. 2019-263 and informed members she was unware about the proposed ordinance to abolish the Citizen Advisory Commission on Alternatives to Incarceration. Ms. Reed stated she disagreed with the ordinance language that the commission had completed its work.

Elizabeth Roark spoke in opposition to Ord. 2019-270 and asked Council to protect existing property owners in Monroe Ward. Ms. Roark expressed her concerns regarding parking if new developments occur in Monroe Ward. Ms. Roark suggested the city establish restricted parking districts in the area to protect the livability of Monroe Ward.

Betty Foglesong, addressed Council regarding Ord. 2019-270, and stated she supported the idea of new developments in Monroe Ward, but was concerned with the impact on parking availability. Ms. Fogelsong suggested parking permits be required to park in Monroe Ward.

Councilor Kim Gray addressed the issue of parking in Monroe Ward and noted the role parking availability has on home values. Councilor Gray stated she hoped that developers work with current residents in the area to address parking.

Councilor Gray informed Council she was concerned with the abolishment of the Citizen Advisory Commission on Alternatives to Incarceration, because the request for abolishment did not include a final report indicating the commission's work had concluded. Councilor Gray added that she expressed her concerns at the September 24th and October 22nd Public Safety Standing Committee meetings.

Councilwoman Reva Trammell stated she wanted to address the effectiveness of current boards and commissions, and indicated she wanted to work with Councilmembers and the Office of City Clerk to examine the necessity of certain boards and commissions.

Councilor Ellen Robertson stated the Citizen Advisory Commission on Alternatives to Incarceration lacked full membership and had difficulty reaching a quorum. Councilor Robertson also stated she hoped to establish a new method to address the issue of incarceration prevention in the future.

Councilor Kristen Larson expressed her reluctance to support abolishment of the commission. Councilor Larson suggested improvements be made to the existing commission instead of creating a new method to address incarceration prevention.

Councilor Chris Hilbert moved to continue ORD. 2019-263 to the Monday, January 13, 2020, City Council meeting, which was seconded and unanimously approved.

There were no further comments or discussions and the **Consent Agenda was unanimously** adopted, with the exception of ORD. 2019-263.

Councilor Parker Agelasto suggested the Richmond Police Department and former Commonwealth Attorney Michael Herring be contacted regarding mayoral vacancies on the Citizen Advisory Commission on Alternatives to Incarceration.

Charles Willis, United Communities Against Crime, spoke in support of the proposed ordinance and referenced recent victims of gun related violence within the city. Mr. Willis also expressed his support of a firearm abuse law similar to child and domestic abuse laws.
