## **Short-Term Rentals Draft Regulations Survey**

Short-Term Rentals (STRs) are rentals of a room or rooms in a dwelling unit for less than 30 consecutive days. Often these rentals are advertised and processed through online platforms such as Airbnb, HomeAway, and VRBO. In the City of Richmond, STRs are currently not identified as a permitted use in the City's Zoning Ordinance and are, therefore, prohibited.
