Mark Olinger, Planning and Development Review director, was available to answer questions regarding Ord. 2019-343 and stated that the city's website will be updated with additional information pertaining to short-term rentals.

Councilor Kim Gray introduced Ord. 2019-352.

Councilor Ellen Robertson stated that she will support Ord. 2019-352; however, she requested that there is community awareness regarding the proposed legislation once adopted.

Mark Olinger, Planning and Development Review director, was available to answer questions regarding Ord. 2019-352.

Richmond Public Schools (RPS) Superintendent Jason Kamras addressed Council regarding Ord. 2019-331 and stated that the proposed legislation would enable RPS to staff and implement programs and processes needed to execute the Dreams4RPS strategic plan.

There were no further comments or discussions concerning Consent and Regular Agenda items reviewed.

#### General Assembly (GA) Update

Ron Jordan, council lobbyist, Advantus Strategies, provided Council with a presentation regarding regional transportation funding issues and HB 1541 being considered during the 2020 General Assembly session. A copy of the presentation provided has been filed.

Mr. Jordan advised Council that the enactment of HB 1541 would provide the city with additional funding for transportation through the creation of the Central Virginia Transportation Authority, which will administer funding generated through the imposition of an additional 0.7 percent retail sales and use tax and a 2.1 percent wholesale gas tax.

Councilor Kim Gray suggested that HB 1541 be vetted by the Richmond Area Metropolitan Planning Organization.

Laura Bateman, council lobbyist, Advantus Strategies, provided Council with an update on gaming bills being considered during the 2020 General Assembly session. A copy of the information provided has been filed.

President Cynthia Newbille requested further discussion regarding the city's impact from a casino and "grey machines" (unregulated electronic gaming machines) at a future meeting, and she asked that Council be provided a matrix of current GA bills.

#### **Closed Session Motion**

Prior to entertaining a motion to enter into a closed meeting, President Cynthia Newbille and Interim City Attorney Haskell Brown clarified the intent of the potential motion.

After further discussion, Councilor Michael Jones moved that the City Council go into a closed meeting pursuant to Sections 2.2-3711(A)(3) and 2.2-3711(A)(29) of the Virginia Freedom of Information Act to discuss the disposition of publicly held real property as part of the proposed Navy Hill development and the terms and scope of a public contract involving the expenditure of public funds for the proposed Navy Hill development where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the City Council.

The motion was seconded and failed: Ayes 3, Jones, Addison, Newbille. Noes 5, Larson, Lynch, Gray, Trammell, Hilbert. Robertson was excused.

Councilor Stephanie Lynch summarized her constituents' apprehensions regarding the proposed Navy Hill Development (NHD) project, which she cited as three major concerns, (i) the process by which the project was developed, (ii) skepticism of the TIF (tax increment financing) and (iii) determining the types of development to be included.

Councilor Kristen Larson shared that her constituents have also stressed concerns regarding financing of the NHD project. Ms. Larson questioned city administration only having the authority to approve and/or waive certain contract conditions if Council approves the development proposal, and the introduction of a bill by Delegate Jeffrey Bourne to create a special tax zone in favor of the project.

President Cynthia Newbille delineated the following shared comments and benefits of the NHD project:

- An increase in affordable housing by at least 15 percent and an acceptance of housing vouchers of 50 percent within the project
- A reduction in the TIF development area

- An increase of minority business enterprise participation of 35 percent for the entirety of the project
- A commitment to hiring city residents and businesses, offering a living wage and benefits, and extending internships and employment opportunities to Richmond Public Schools students
- Location and construction finalization of a bus transfer plaza
- Assistance with the relocation of city service departments such as Social Services
- Coordination of citywide outreach within several city departments

Councilor Kim Gray questioned Council's ability to discuss possible negotiation efforts when there are still unknown factors surrounding the NHD project.

President Newbille reiterated the timeline for evaluating the proposed Navy Hill Development project.

#### Adjournment

There being no further business, the meeting adjourned at 5:54 p.m.
