President Cynthia Newbille called the meeting to order at 6:06 p.m., and presided.

Invocation was offered by Reverend Charles "Charlie" T. Dupree of St. Paul's Episcopal Church, 815 East Grace Street, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

CHAMBER EMERGENCY EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

Councilor Michael Jones, on behalf of Richmond City Council, recognized and honored the Richmond Department of Parks, Recreation, and Community Facilities Richmond Southside Community Center under 12 Youth Football Program, the Ducks football team, for its successful season which included winning the 2019 Richmond Department of Parks, Recreation, and Community Facilities under 12 City Youth Football Championship and participating in the Snoop Youth Football League National Championship held in Los Angeles, California.

Councilor Michael Jones, on behalf of Richmond City Council, recognized and honored the Excel to Excellence Youth Football League Junior 14 and Under Youth Cheerleading Program, All Star Cheer Squad, for its successful inaugural season which included participating in the Snoop Youth Football League National Championship held in Los Angeles, California.

CITIZEN COMMENT

James Minor addressed Council regarding the need for economic development in the city. Mr. Minor expressed his frustrations with the limited number of commercial retail stores within the city. Mr. Minor stated people needed to come together to address poverty.

Sandra Antoine addressed Council and shared her appreciation for Mayor Levar Stoney. Ms. Antoine stated the restaurant meals tax advocated by Mayor Stoney had benefited the city.

Charles Willis, United Communities Against Crime (UCAC) executive director, addressed Council regarding violence within the city. Accompanying Mr. Willis were family members of victims who lost their lives due to violence. Mr. Willis stated UCAC assisted families victimized by violence and helped organized vigils and funerals. Mr. Willis also stated UCAC struggled to accommodate these efforts due to lack of funding and requested help with funding or donations.

Councilwoman Reva Trammell thanked Mr. Willis for his efforts and asked that he inform Council of specific needs.

Mr. Willis stated UCAC was in need of balloons, candles, clothing, an audio system, and a computer.

Councilor Michael Jones expressed his hope that Council would provide UCAC with funding through the city's budget.

Kanika McBride addressed Council and alleged members of her family were victims of mistaken identity by the Richmond Police Department (RPD) which resulted in a confrontation between her family and police officers. Ms. McBride also stated RPD's records management system should diminish situations such as mistaken identity.

President Cynthia Newbille stated her upcoming Council district meeting would address public safety and invited Ms. McBride to attend.

Councilwoman Trammell also invited Ms. McBride to the January 28, 2020, Public Safety Standing Committee meeting.

Kim Rolla, Legal Aid Justice Center attorney, Richmond Transparency Accountability Project member, addressed Council regarding RPD's records management system. Ms. Rolla expressed her belief that a public forum was necessary to provide citizens an opportunity to share views regarding the records management system.

Councilor Kim Gray informed Council the issue of scheduling a public forum was addressed multiple times in prior Public Safety Standing Committee meetings.

Councilwoman Trammell suggested the Public Safety Standing Committee coordinate an open forum.

Police Chief William Smith addressed Council and stated the implementation process for the records management system was taking longer than anticipated. Chief Smith also stated a public forum was held, but admitted it was poorly advertised.

President Newbille requested that the Public Safety Standing Committee organize a public forum on the RPD records management system.

Councilwoman Reva Trammell expressed her concern that the Blackwell Historic Community Civic Association (BHCCA) was not consulted regarding ORD. 2019-324. Councilwoman Trammell requested that consideration of the ordinance be continued to allow more discussion.

Mark Olinger, Planning and Development Review director, stated the BHCCA was informed about ORD. 2019-324 and no response was received.

Interim City Attorney Haskell Brown informed Council that a motion to reconsider the adoption of the Consent Agenda was necessary to continue ORD. 2019-324.

Councilwoman Reva Trammell moved to reconsider the Consent Agenda, which was seconded and approved: Ayes 8, Jones, Robertson, Larson, Lynch, Gray, Addison, Hilbert, Newbille. Noes 1, Trammell.

Councilwoman Reva Trammell moved to continue ORD. 2019-324 to the Monday, January 27th Council meeting, which was seconded and unanimously approved.

REGULAR AGENDA

ORD. 2019-352

To amend section 30-800.3 of the City Code, concerning changes in nonconforming uses, for the purpose of requiring a minimum lot area of 750 square feet per dwelling unit when a nonconforming use is changed to a multifamily dwelling within certain residential zoning districts.

Councilor Kim Gray provided an introduction to ORD. 2019-352.

Opposition

Doug Allen, American Institute of Certified Planners, spoke in opposition to ORD. 2019-352 and stated the proposed ordinance would restrict much needed housing opportunities within the city. Mr. Allen expressed his belief that ORD. 2019-352 was a legislative overreach to address a particular development.

Samantha Ladin spoke in opposition to ORD. 2019-352 and thanked Council for moving consideration of the ordinance to the Regular Agenda. Ms. Ladin expressed her belief that committee deliberation of proposed legislation should not occur during the work day, but during a time more accessible to the public.

Justin Hazelworth spoke in opposition to ORD. 2019-352 and stated due to a housing crisis in the city more mixed-income housing opportunities should be available.

Adam Lockett spoke in opposition to ORD. 2019-352. Mr. Lockett stated he was aware the ordinance would only effect 100 properties in the city, but he believed that was 100 too many.

Daniel Klein spoke in opposition to ORD. 2019-352 and stated that increased housing density raises real estate tax revenue for the city without raising the real estate tax rate. Mr. Klein stated housing density would allow the city to address the increased migration of individuals to the city.

Support

Jerome Legions spoke in support of ORD. 2019-352 and stated more housing opportunities were necessary for single family homes and not apartment buildings.

Omari Al-Qadaffi spoke in support of ORD. 2019-352 and stated increased density creates parking issues for longtime residents in proposed development areas. Mr. Al-Qadaffi also stated small businesses do not have resources to provide parking for customers.

Robert Liddell, West Grace Street Association president, spoke in support of ORD. 2019-352 and stated the ordinance was reasonable and properly vetted.

Charleen Baylor spoke in support of ORD. 2019-352 and stated the ordinance would protect against gentrification. Ms. Baylor also stated developers could still request special use permits if a proposed development does not comply with ORD. 2019-352.

Janis Allen, Historic Jackson Ward Association president, spoke in support of ORD. 2019-352 and stated the ordinance would require developers to work with communities regarding potential developments that required a special use permit.

Jerry Beverage, Fan District Association president, spoke in support of ORD. 2019-352 and stated too much density created issues with increased traffic, parking, noise and trash. Mr. Beverage expressed his belief that the ordinance was properly vetted and met an appropriate balance.

Steve Nuckols, Monument Avenue Preservation Society member, spoke in support of ORD. 2019-352 and stated the ordinance would keep development in check.

Preston Lloyd spoke in support of ORD. 2019-352 and stated the ordinance met an appropriate balance regarding density development in the city.

Rodney Poole spoke in support of ORD. 2019-352 and stated the ordinance created clarity on non-conforming use conversions.

Councilor Gray stated increased density created issues that forced longtime home owners to move away from their established neighborhoods.

Councilor Michael Jones inquired about the impact if the minimum lot area of 750 square feet per dwelling unit referenced in ORD. 2019-352 was reduced to 500 square feet.

Mark Olinger, Planning and Development Review director, stated the reduction in square footage would increase the number of units by 50% and would increase issues such as parking and trash by 50%.

Councilor Ellen Robertson stated her original preference was for a minimum lot area of 500 square feet, but after speaking with Planning and Development Review she was satisfied with 750 square feet.

Councilor Stephanie Lynch stated she originally opposed ORD. 2019-352, but was made aware the purpose of the ordinance was to close a loophole and now supported ORD. 2019-352.

President Cynthia Newbille stated she had questions about ORD. 2019-352, but was comfortable with the ordinance being adopted.

There were no further comments or discussions and **ORD. 2019-352 was unanimously adopted.**
