THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Chapter 12, Article IV of the Code of the City of Richmond (2015) be and is

hereby amended and reordained by adding therein a new section numbered 12-123 as follows:

Sec. 12-123. Police law enforcement services for special events.

A fee as set forth in Appendix A to this Code shall be assessed by the City, through the Department of Police, for each employee who provides law enforcement services at a special event. The City, through the Chief of Police or the written designee thereof, shall enter into a contract

with the holder of the special event for the provision of the services and the payment of the fees. A minimum of four hours per employee shall be charged for each special event for which such services are requested. Such fee shall be prorated for the time for which such services are actually rendered, but in no case shall the fee be less than an amount equal to four hours per employee. For the purposes of this section, the term "special event" shall mean an event in the City that is organized to attract participants or spectators from the public.

§ 2. That Appendix A of the Code of the City of Richmond (2015) be and is hereby amended and reordained by **adding therein new** fees for section 12-123 of the Code of the City of Richmond (2015) as follows:



#### **PURPOSE:**

To amend the City Code to establish fees for services rendered by Richmond Police Department (RPD) officers for special event assignments throughout the City and to amend the FY2020 General Fund Budget council ordinance 2019-041 by appropriating \$350,000\_in Police Special Event fees above the adopted budget amount to the Richmond Police Department.

#### **REASON:**

To charge for specialized staffing services performed by RPD at special events held within the City of Richmond. The appropriation of these funds will allow the Richmond Police Department to pay overtime costs associated with providing law enforcement activities for designated special events.

#### **RECOMMENDATION:**

The City Administration recommends adoption of this ordinance.

# **BACKGROUND:**

RPD provides services at some of the largest special events held within the City of Richmond. A special event is defined as an organized venue designed to attract participants or spectators, or both. These special events can attract tens of thousands of spectators and require officers to provide services at the event, including, but not limited to, providing security and controlling crowds and traffic. In order to adequately staff these large scale events, RPD must compel law enforcement officers, sometimes exceeding 100 law enforcement officers for a single event, to work mandatory overtime and requires the use of RPD equipment.

Under § 2.05(g) of the Richmond City Charter, the City may "establish and collect such fees...as may be determined by the council to be reasonable for the rendering of special services." Even though the City has the power to collect these fees, none of the City's current ordinances address contracts between RPD and special event organizers.

The requested ordinance will authorize the City to contract with holders of special events for the provision of services by RPD law enforcement officers in exchange for a fee. The fee will be assessed against the holder of a special event for the use of City equipment and as reimbursement to the City for the compensation paid to the law enforcement officers for providing services at the special event. The fee for the use of a RPD vehicle will be \$35 per day, per vehicle. The fee for the services provided by law enforcement officers will be the total of each officer's personal hourly rate multiplied by each hour worked or each fraction thereof multiplied by 1.5. A minimum of four hours per law enforcement officer will be charged for each event.

FISCAL IMPACT / COST TO CITY: There is no cost to City.

**FISCAL IMPLICATIONS:** The Richmond Police Department will utilize the fees collected to offset the personnel and equipment costs associated with the event.
