# Summary:

- The Patron believes that speeding in this area endangers pedestrians and vehicular traffic.
- Manchester is one of the City's fastest growing neighborhoods. The increase of residents in the neighborhood has led to an increase in commuters, pedestrians, and families with children playing outside.

- The community within this neighborhood has requested the installation of multiple 4 way stop signs and painted bars as a means to increase safety for children and pedestrians.
