PURPOSE: To authorize the City's Acting CAO to accept funds in the amount of \$375,000 in FY 2020 from the United States Department of Justice and to create the Commonwealth's Attorney FY 2020 Elder Abuse Prevention Special Budget Fund by appropriating the same for the purpose of accepting the Grant Award from the Department of Justice.

REASON: The City of Richmond will receive \$375,000 in FY 2020 from the United States Department of Justice because of a successful grant application to the Department of Justice. The grant specifically targets the reduction of Elder Abuse in the City of Richmond. The City will receive \$375,000 over a three-year period. It is requested that an Elder Abuse Prevention Special Budget Fund be created and that the money be placed in the fund. The money will be disbursed over three years as outlined in the Budget Spreadsheet attached to this request.

RECOMMENDATION: It is the recommendation of the Administration that City Council approves and adopts this ordinance.

BACKGROUND: This grant was applied for during the summer of 2019, and was granted in October of 2019. The anticipated amount is \$375,000 over a period of three years. Because this item was not placed in the budget previously, the additional grant funds must now be accepted and appropriated.

FISCAL IMPACT: The City of Richmond will receive, over three years, \$375,000 in unexpected funding from the Department of Justice to work to reduce Elder Abuse in the City of Richmond.

FISCAL IMPLICATIONS: The acceptance of this award will increase the Commonwealth Attorney's FY 2020 Special Fund Budget by \$375,000.
