## THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That section 12-94 of the Code of the City of Richmond (2015) be and is hereby amended and **reordained** as follows:

## Sec. 12-94. Reservation of picnic shelter [and rental fee for picnic packs].

A fee as set forth in Appendix A to this Code shall be charged and paid into the City treasury for the <u>reservation of picnic shelters</u> [rental of picnic packs (a duffle bag with games and sporting equipment for use by groups or individuals at picnics) by non-City agencies,

organizations and individuals, such fee to aid in the operation and maintenance of public facilities. Also, as set forth in Appendix A to this Code, a refundable deposit shall apply to all rentals, which will be refunded upon the return of the picnic packs in good condition with all equipment].
