
THE CITY OF RICHMOND HEREBY ORDAINS:

ORDINANCE/RESOLUTION SUMMARY

The patron requests that legislation be drafted for Council's consideration to designate the attached parcels to be added to the Canoe Run Park.

BACKGROUND

Canoe Run Park sits between Semmes Ave. and Riverside Drive at West 22nd Street in South Richmond. A third of the park, while currently programmed as park space, is not listed as park property. The patron believes that the parcels should be listed as park property and it should be under the control of the Department of Parks, Recreation and Community Facilities. The neighborhood and the patron wants to protect this green space.

Attached is a listing of the current park footprint and the parcels to be added to the park as park property.
