President Cynthia Newbille called the meeting to order at 6:00 p.m., and presided.

ELECTRONIC MEETING ANNOUNCEMENT

City Clerk Candice Reid, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, announced the meeting would be held through electronic communication means. City Clerk Reid stated notice of the meeting was provided to the public through a public information advisory issued on May 14, 2020, and through Legistar on the city website in accordance with usual practice. She also stated members of the public were encouraged to provide comments in writing prior to the meeting and all comments received prior to 10:00 a.m., on Tuesday, May 26, 2020, were provided to Council members. Ms. Reid indicated that members of the public who signed up to speak and provide comment would be called to speak at the appropriate time.

Invocation was offered by Rabbi Michael R. Knopf of Temple Beth-El, 3330 Grove Avenue, Richmond, VA.

Members of Council and staff recited the Pledge of Allegiance.

CITIZEN SPEAKER GUIDELINES

Upon the President's request, Deputy City Clerk RJ Warren provided citizen speaker guidelines.

Councilor Andreas Addison joined the meeting at 6:05 p.m.

APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

There were no awards or presentations.

CITIZEN COMMENT

It was the consensus of Council to allow individuals that had signed up to provide public comment regarding **Ord. 2019-343** and **Res. 2020-R034**, prior to Council's decision to continue consideration of both items, to provide public comment during the citizen comment period.

Citizens were provided an opportunity to offer comments in writing regarding **ORD. 2019-343** and **Res. 2020-R034** prior to the Formal City Council meeting and public hearing. All written comments received by the Office of the City Clerk were provided to members of the Council prior to the meeting and are included as an Appendix to the May 26, 2020 Formal City Council meeting minutes.

Councilor Michael Jones joined the meeting at 6:07 p.m.

Vice President Chris Hilbert joined the meeting at 6:08 p.m.

Thomas Courtney addressed Council and expressed his concerns regarding **Ord. 2019-343**. Mr. Courtney provided data regarding the proposed ordinance and stated a majority of short term rental operators would have to cease operations if the ordinance was adopted.

Tyler Rackley addressed Council and expressed his concerns regarding **Ord. 2019-343**. Mr. Rackley stated he appreciated Council's decision to continue consideration of Ord. 2019-343, and that he believed it would provide enough time to address potential amendments regarding the principal occupancy requirement referenced in the proposed ordinance. Mr. Rackley also stated he believed nearly 80% of short term rental operators were using second homes and not primary residences as short term rental space.

Stacie Vanchieri addressed Council and expressed her concerns regarding **Ord. 2019-343**. Ms. Vanchieri stated if Ord. 2019-343 was adopted as currently drafted, it would decimate nearly 80% of the short term rental operators in the city. Ms. Vanchieri informed Council she believed that tourists who visit the city want the ability to rent entire homes and not single rooms

Allan-Charles Chipman addressed Council regarding **Res. 2020-R034**, and expressed his support for Council's decision to continue consideration of the proposed resolution. Mr. Chipman stated he believed a small area plan and appraisals of city-owned property should have been completed before the city declared the city-owned property referenced in Res. 2020-R034 as surplus property. Mr. Chipman also stated more public input was necessary before action was taken on city-owned property.

Sebastian Shetty, Partnership of Smarter Growth member, addressed Council regarding **Res. 2020-R034**, and stated Council should allow more public input before the city-owned property referenced in Res. 2020-R034 is declared as surplus property. Mr. Shetty also stated due do the impact of the COVID-19 pandemic, consideration of the proposed resolution should be continued to allow for an effective public review process of the proposed resolution.

Councilor Kristen Larson expressed her concerns regarding historic preservation, and stated the issue regarding historic preservation at George Mason Elementary School, should have been resolved prior to the start of school construction.

This is a follow up to several comments I have made, including a detailed letter from me earlier this year. I would urge your support of the proposed STR guidelines, including any amendments that would make it more restrictive and/or add stronger fees and sanctions for violators.

The key is the Primary Residence provision. This solves the original intent of STR discussion for the owner seeking to supplement their income while at the same time preventing the commercial operator from encroaching into residential neighborhoods. While the commercial operators have put forth their points in a compelling presentation, the blanket approval would allow any commercial operator, not just the examples they shared, to run a business. There is no prohibition against any of them applying individually in the future to obtain a STR through the Zoning Variance process.
