PROJECT LOCATIONS

- (1) Hull St. & 11th St. along the Hull St corridor
- (2) Lynhaven Ave. and Wright Ave. in the Oak Grove-Bellemeade neighborhood.

PROJECT PURPOSE

To provide traffic-calming interventions at well-traveled pedestrian and bicycle routes including local businesses and Hull St. Public Library along the Hull St. corridor, the Oak Grove-Bellemeade Community Center, the Oak Grove-Bellemeade Elementary School, and transit stops at both intersections.

SUMMARY & RECOMMENDATION

Background:

Through prior community engagement efforts, traffic calming has been identified as a need in these areas. Installation of road murals have demonstratively succeeded in calming vehicular traffic through neighborhoods in the interim of longerterm locality planning, funding and installation of more permanent traffic calming measures. By installing these intersection murals, drivers' attention will be drawn to the intersection, slowing their driving speed and increasing their observation of pedestrian and bicyclist movement in the area and thereby reducing the likelihood of pedestrian or bicyclist-involved crashes.

The artist commissioned for this project is Silly Genius, a Richmond-based artist and founder of the local collaborative, All City Art Club. The collaborative exists to bridge the gap between community and citizens by introducing street art to underserved communities without the goal of tourism or gentrification. Its goal is to make people feel good about where they live. The club has completed numerous murals throughout Richmond, with particular attention to Southside. The Club's portfolio includes works at the Broad Rock Community Garden (Broad Rock and Stockton St), Mending Walls Project Mural #2 located at Commonwealth Law Group (Broad St), Atlantis Food Service Equipment (Hull St), and Seafarm Seafood (Hull St) (www.allcityartclub.com/projects).

Correlation to Public Art Master Plan:

- Involves temporary "commissions" (p 8)
- Encourages community-based involvement in a public art project (p 7 & 8)
- Distributes public art equitably and delivers public art to more diverse communities (p 55)

Recommendation:

Staff recommends approval of the project's conceptualization and locations with the following conditions:

1. The petitioner shall be responsible for obtaining and adhering to all necessary permissions and permits for the project as required by the Department of Public Works.

- Verify that the property is, in fact, City-owned;
- Help identify what City agency(ies) you must contact for permits;

You are also strongly encouraged to contact the location's City Council representative, the pertinent civic association, and/or residents or merchants who may be affected by the proposal—the more community support your project has the stronger your proposal will be.

Installation cannot begin until a final approval has been granted and all City permits have been secured.

SUBMITTING YOUR APPLICATION:

Your application may be emailed to the contact information at the top of this page. Only digital applications will be accepted.

Applications must be submitted at least 10 business days in advance of the next available PAC meeting. These meetings are schedule on the 4th Thursday of most months.

WHAT HAPPENS NEXT:

PAC Review and Recommendation

The PAC reviews your proposal at the first available Commission meeting. You are welcome to present your proposal in person at the meeting and answer any questions posed by Commissioners (though you are not required to attend). Following a discussion, the PAC either (1) recommends the proposal, (2) recommends the proposal with contingencies (meaning you may need to make specified modifications to the proposal), or (3) rejects the proposal. The PAC then passes the proposal and its recommendation on to the Planning Commission for a final decision.

Planning Commission Approval

The Planning Commission reviews the proposal at their next available meeting following PAC action. The Planning Commission meets the first and third Monday of the month. You are not required to attend this meeting but you may wish to attend to address any Commission questions. The Commission then votes to approve or reject the proposal.

Installing the Art

After receiving a final approval from the Planning Commission—*but before installing the art*—you are responsible for securing any needed City permits such as work in street permits or electrical/plumbing/structural inspections to ensure the installed art complies with all City regulations and necessary safety and structural precautions.
