Acting Chief Administrative Officer Lenora Reid informed Council that since the Commonwealth Attorney state and federal asset forfeiture special funds are reported annually, additional reporting would be required with the adoption of Res. 2020-R046.

Interim City Attorney Brown stated that his office would not be able to draft an amendment to Res. 2020-R046 for consideration later that evening at the Formal Session of Council.
