Council President Cynthia Newbille called the meeting to order at 6:03 p.m., and presided.

Invocation was offered by Dr. Sheary Johnson of Victory Family Worship Center, 30 LaBrook Drive, Richmond, VA.

Councilor Stephanie Lynch joined the meeting at 6:08 p.m.

Members of Council and the audience recited the Pledge of Allegiance.

ELECTRONIC MEETING ANNOUNCEMENT

City Clerk Candice Reid, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, announced the meeting would be held through electronic communication means. City Clerk Reid stated notice of the meeting was provided to the public through a public information advisory issued on May 28, 2020, and through Legistar on the city website in accordance with usual practice. She also stated members of the public were encouraged to provide comments in writing prior to the meeting and all comments received prior to 10:00 a.m., on Monday, June 8, 2020, were provided to Council members. Ms. Reid indicated that members of the public who signed up to speak and provide comment would be called to speak at the appropriate time.

CITIZEN SPEAKER GUIDELINES

President Cynthia Newbille informed members that 18 individuals signed up to speak during the Citizen Comment Period and inquired if members had any objection to allowing the additional 10 speakers to provide public comment.

It was the consensus of Council to allow the additional public comment speakers and to limit the usual three minutes offered to provide public comment to two minutes.

Upon the President's request, Deputy City Clerk RJ Warren provided citizen speaker guidelines.

The motion was seconded and was approved: Ayes 7, Jones, Larson, Lynch, Gray, Trammell, Addison, Newbille. Noes None. Robertson was excused.

AWARDS AND PRESENTATIONS

There were no awards or presentations.

CITIZEN COMMENT

Citizens were provided an opportunity to offer comments in writing prior to the Formal City Council meeting. All written citizen comments received by the Office of the City Clerk were provided to members of the Council prior to the meeting, and are included as an appendix to the June 8, 2020 Formal City Council meeting minutes.

Kathryn Brown addressed Council and expressed her support for the removal of all Confederate monuments within the city. Ms. Brown stated the removal would help eradicate white supremacy in the city.

Mera Carle addressed Council and requested the reallocation of Richmond Police Department (RPD) funds to schools, community programs and living wage jobs. Ms. Carle also requested the implementation of a *Marcus Alert* to assist individuals suffering from a mental health crisis. Ms. Carle stated she wanted the officers responsible for dispersing tear gas on protesters at the Robert E. Lee monument to be removed from the field.

Ebony OpongBrown, Three Girls with a Message (3GM) member, addressed the positive atmosphere among people protesting within the city. Ms. OpongBrown requested Council assist with declaring July 5, 2020 as a day to uplift black owned restaurants in the city.

John Bradley addressed Council and expressed his belief that the Richmond Police Department's interaction with protesters was an anti-democratic betrayal of the public trust. Mr. Bradley requested Council defund the RPD and redirect funds to schools, housing and the public good.

David Robinson addressed Council and informed members he was a United States Marine Corps veteran requesting police reform. Mr. Robinson stated the use of military equipment by police was eroding the public's trust. Mr. Robinson expressed his belief that higher education requirements should be necessary for prospective police officers to receive employment.

Marshal Turner addressed Council and referenced the death of Marcus-David Peters. Mr. Turner requested Council defund the RPD and that funds be reallocated to address mental health in minority communities.

Talal Bitar addressed Council and expressed his concerns with the amount of funds allocated to the Richmond Police Department. Mr. Bitar requested police officers be held accountable and that funding should be reallocated from the RPD to improve human services.

Jason Douglass Reed addressed Council and informed members that a proposed bike lane on the 4400 hundred block of Patterson Avenue would remove all public access parking to residents of the street. Mr. Reed stated those with mobility issues would be negatively impacted with the lack of parking available due to the addition of a bike lane. Mr. Reed requested Council suspend construction of the bike lane pending review of a proposal for an alternative location for the bike lane.

Hilary Small addressed Council and shared her support for the removal of Confederate monuments within the city. Ms. Small requested the removal of police officers from schools, defunding of the RPD and the reallocation of funds towards community care.

Kathleen Thompson addressed Council and commended members for their commitment to the removal Confederate monuments within the city. Ms. Thompson requested less financing for the RPD in order to reallocate funds towards mental health services, affordable housing, workforce development and school funding.

Leslie Johnson addressed Council and spoke to the experiences people of color face within the city. Ms. Johnson requested that the RPD require a two year degree in criminal justice from prospective police officers.

Viktoria Chronister addressed Council and stated people needed to take the opportunity to be educated in the experiences of others. Ms. Chronister expressed her hope that the city could be an example to others for how to promote positive change.

Jayqua Williams addressed Council and shared the experiences she faced as a black child in the city. Ms. Williams stated the interactions between black youth and police needed to improve. Ms. Williams also stated she was collecting experiences and grievances regarding racism and police brutality. Ms. Williams further stated she hoped to share the results with members of Council.

Parth Sheth addressed Council and expressed his concerns with the RPD's actions regarding protesters in the city. Mr. Sheth requested Council create meaningful mental health response teams, replace the chief of police, defund the RPD and reallocate funds towards city services.

Councilor Michael Jones shared his appreciation of individuals who provided public comment and citizens participating peacefully in protests. Councilor Jones stated funding for public safety needed to be re-examined and that a transparent discussion about the amount of funding allocated to the RPD was necessary.

Public Hearing

Blake Gayle, Zwerdling, Oppleman & Adams attorney, on behalf of the property owner of 1201 Porter Street, spoke in opposition to Ord. 2020-111 and Ord. 2020-124. Mr. Gayle stated his client was not properly notified by the city regarding the blight complaint and therefore the ordinances before Council for consideration were invalid. Mr. Gayle also stated he believed his client should be provided more time to respond to the city's attempt to declare 1201 Porter Street a blight property due to the COVID-19 pandemic.

Tychelle Brown spoke in support of Res. 2020-R037, and the need to assist the homeless population within the city. Ms. Brown stated many in the homeless population suffered from mental health issues and requested the city provided additional services within that community.

Councilor Kristen Larson inquired about the legal issues referenced by Blake Gayle.

Interim City Attorney Haskell Brown informed members that nothing prohibited Council from considering Ord. 2020-111 and Ord. 2020-124, and that no court had issued an order that prevented the city from moving forward on declaring 1201 Porter Street a blighted property.

Mark Olinger, Planning and Development Review director, informed Council he believed the city took all appropriate steps to notify the property owner of 1201 Porter Street.

Councilor Stephanie Lynch requested an update from city partners regarding steps taken to address and assist the homeless population within the city.

There were no further comments or discussions and the **Consent Agenda was unanimously adopted.**

Fire Chief Melvin Carter provided additional information regarding the proposed resolution and stated the resolution would provide the mayor with the authority to ensure public safety.

Councilor Kristen Larson inquired what additional authority the resolution would provide that was not previously granted by Res. 2020-R025, adopted March 16, 2020, which authorized an emergency declaration due to the COVID-19 pandemic.

Chief Carter informed Council the city could not rely on the previously granted pandemic emergency declaration to address civil unrest within the city. Chief Carter stated the resolution would aid first responders with emergency response time in the city.

There were no further comments or discussions and **Res. 2020-R041 was unanimously adopted**.

Councilor Ellen Robertson moved to expedite consideration of the following resolution, which was seconded and unanimously approved:

RES. 2020-R042

To express the Council's support for the Governor of Virginia's executive order requiring that face coverings be worn in public indoor areas to reduce the spread of the COVID-19 virus.

Patron: Mr. Jones

Councilor Michael Jones provided an introduction of Res. 2020-R042 and stated the proposed resolution would promote safety within the city regarding the COVID-19 pandemic.

It was the consensus of Council members present to be added as co-patrons of Res. 2020-R042.

Councilor Kim Gray requested additional information regarding when additional personal protective equipment supplies would be available for distribution.

Thank you for taking the time to read my proposal for the future beautification of Monument Avenue. There is of course plenty of discussion about the removal of these racist statues, and I would like to propose their replacements.

First, we begin with Stonewall Jackson. He should be replaced by Arthur Ashe. The Arthur Ashe statue at the Roseneath Road intersection is not perfect, but it makes sense for him to stand on the newly renamed Arthur Ashe Boulevard. (To fill the space where Arthur Ashe's current statue is, I recommend honoring the Powhatan people, on whose land we currently reside. We should commission an indigenous artist to create this monument.)

Second, we have Jefferson Davis. I personally believe that the general structure of this statue is aesthetically pleasing. We could keep the semi-circle and the tower. We would simply remove the statue of Jefferson Davis and replace the plaques with better contextual information.

Next, we have the largest, most prominent statue: Robert E. Lee. I recognize this is the property of the Commonwealth, but I would be remiss if I didn't incorporate this into my proposal. Robert E. Lee should be replaced with a beautiful, peaceful, as eco-friendly-aspossible fountain. It is unproductive to replace a terrible man with a less terrible man. We need to recognize that no human is perfect, and therefore we should stop glorifying any person, no matter how great they look in our present cultural lens.

And finally, the easiest decision of all. We must replace J.E.B. Stuart with Rumors of War by Kehinde Wiley. This statue was modeled after the Stuart statue and it is only fitting that this should be the replacement.

Thank you for your time. I look forward to hearing from you. If you have information about who else I should contact and how I can get involved in the planning process, that would be greatly appreciated.

My name is Ember Ashley, and I am submitting a public comment in regards to the Records Management System Agreement between the Richmond Police Department (RPD) and the VCU Police Department (VCUPD).

As a recent graduate of Virginia Commonwealth University, I urge you to oppose this proposition. The most egregious clause, Article III, Section C., states: "The Parties acknowledge that VCUPD may have access to certain student information from "education records" protected by the Federal Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. §, 34 CFR Part 99) and Code of Virginia Section 23.1-405(C) and certain patient information protected by the Health Insurance Portability and Accountability Act (HIPAA) (Public Law 104-191)".

There is no conceivable necessity for RPD to have proximate access to any information protected by FERPA or HIPAA. I consider it a flagrant invasion of privacy that runs counter to public safety, and the method proposed (destroying records) to "remedy" the possible disclosure of protected information is nowhere near sufficient, especially if the damage has already been done.

We cannot erode the barrier of these legal protections just for the ease of communication between RPD and VCUPD. This agreement does not benefit VCU's ability to provide education, safety, or security to its students.

Dear Ms. Reid:

I represent David Williams with regard to pending actions by the City of Richmond regarding the real property and improvements located at 1201 Porter Street in the City of Richmond (the "Property"). It is my understanding that the Richmond City Council will be considering an Ordinance on the Property at their meeting at 6:00pm today. Please forward this to the Council members in advance of that hearing.

Mr. Williams has owned the real property located at 1201 Porter Street in the Manchester district since 2002. The structure on the Property is essentially a shell of a brick building built in the late 1800s. By all accounts the structure is a big, beautiful, and rare example of the architecture from its time still standing in Manchester. He has been in communication with the City over the last 3-4 years regarding issues with the property. These issues included maintenance issues and structural concerns, all of which were timely addressed. In December 2019 the City apparently made the preliminary determination that this property was blighted, and on February 10, 2020, the City made a recommendation to move forward with this spot blight abatement action to acquire the property from Mr. Williams.

The applicable laws in this case are Virginia Code §36-49.1:1 and Code of Ordinances of the City of Richmond §5-85. These laws deal with spot blight abatement. In short, the statutes set out a process that a locality must follow in order to acquire and repair a blighted property. Per these laws, once a locality has made the preliminary determination that a property is blighted, they are required to provide a written notice to the owner of record specifying the reasons why the property is blighted and advising that the owner has 30 days from the date of the notice in which to submit a spot blight abatement plan to address the blight within a reasonable time. A "spot blight abatement plan" is defined as a "written plan prepared by the owner of record of the real property to address spot blight."

In this case the City's notice of the preliminary determination of spot blight to Mr. Williams was defective. The statute requires that the notice be delivered to Mr. Williams at his last known address as contained in the records of the treasurer, the current real estate tax assessment records, or the records of such other officer responsible for collecting taxes in that locality. In this case the City claims that a notice dated December 9, 2019, was sent to Mr. Williams by certified mail to the "Grantee's address" listed on the 2002 deed transferring the property to Mr. Williams. The City concedes that the notice was returned in February of 2020 as undeliverable, presumably because the zip code on the correspondence was incorrect. The City concedes that the zip code was incorrect but claims that it was due to a scrivener's error on the deed. However, the statute requires that the City use the address on record in the current real estate tax assessor's records, not the address on the owner's deed. The evidence would show that Mr. Williams has been receiving tax bills for 1201 Porter at his correct home address for years. See his 2019 First Hal Real Estate Tax Bill attached hereto as Exhibit A that was sent to Mr. Williams' correct home address.

Despite the fact that the spot blight notice was returned as undeliverable, on February 10, 2020, Mr. Olinger, Director of Planning and Development Review, in his recommendation to City Council, took the view that "the owner of the blighted property has failed to present or implement an acceptable blight elimination work plan." Nowhere in the recommendation is there any mention that the notice was returned as undeliverable.

In a brief submitted to the Richmond Circuit Court, Counsel for the City suggests that the defective notice was rehabilitated by the fact that Mr. Williams ultimately received actual notice of the spot blight action and was afforded the opportunity to submit a spot blight abatement plan, which was rejected. This is not so.

On March 5, an email was sent to Mr. Williams from Michelle Coward, the City's Property Maintenance Code Enforcement Operations Manager, with the specifications of spot blight attached. However, that email did NOT contain the notice letter dated December 9, 2019, that referenced the spot blight statute and instructed Mr. Williams that he had 30 days to submit a spot blight abatement plan. It would appear that the letter was not included in that email because Mr. Olinger and Ms. Cowards had already determined Mr. Williams to be in default on February 10, 2020, and had already made a formal recommendation to acquire the property.

In its brief to the Richmond Circuit Court, the City claims that a spot blight abatement plan was submitted by Mr. Williams on March 19, 2020, and that it was duly considered and rejected by the City. We agree that work plan was submitted by Mr. Williams on March 19, but it was not a spot blight abatement plan. Mr. Williams would testify that he was instructed by Mr. Olinger and Ms. Coward that he needed to present a plan for full renovation of the building, not just a plan addressing the spot blight. Based on their instruction, Mr. Williams submitted a derelict building work plan on March 19, 2020, contemplating full renovation of the building. Mr. Williams repeatedly followed up with Mr. Olinger and Ms. Coward but heard no response until an April 28, 2020, email from Mr. Olinger advising that the City was moving forward with the spot blight hearing before the Planning Commission on May 4, 2020, pursuant to his February 10, 2020, recommendation. It was not until April 30, 2020, that Ms. Coward emailed Mr. Williams advising him that his work plan was rejected because she felt that it would take too long to complete. Ms Coward did not allow an opportunity for Mr. Williams to revise the work plan to address only the spot blight issues, which would have significantly shortened the estimate duration of the project. Ms. Coward would later testify (at the May 4 hearing) that the work plan submitted by Mr. Williams was rejected because it proposed to take 18 months for full renovation, while the City considers 6 months to be customary for spot blight abatement.

The statute requires that the work plan must propose to abate the blight within a "reasonable time." There is a reason why the statute is worded this way. What is considered a reasonable amount of time will depend on the particular specifications of blight to be abated in each case. Ms Coward's insistence on a 6 month timeframe is arbitrary and does not take into account the condition of this structure, which is essentially a shell of a building. However, Mr. Williams stands ready to submit a spot blight abatement plan within 30 days that contemplates abating the blight within 6 months.

Mr. Williams was not properly notified of this action, and when the City recognized their error they did not provide Mr. Williams with a fair opportunity to present an acceptable spot blight abatement plan. If this Ordinance is passed, then I believe it is very likely that the Richmond Circuit Court will rule it invalid because of these procedural defects.


The City has repeatedly stated in its Planning Commission meetings that its primary objective in this action is to restore the property to a safe and habitable condition so it will be an asset to the neighborhood rather than a blight. Certainly this process will happen more quickly if renovations are completed by a willing and able owner rather than trough the forced acquisition and sale of the property to a developer by the City. The acquisition of the property through the processes outlined in Title 25.1 of the Virginia Code could take a year or more. The advertisement and sale of the property at auction to a developer pursuant to the terms of am approved development plan as required by statute will take an additional 6 months or more. So it would likely be 18 months or more before work could even begin on the property pursuant to the City's current course of action! Whereas, Mr. Williams is ready, willing, and able to present plans to abate the spot blight and to fully renovate the building, all of which would be completed long before the City would be able to effectuate repairs by its current course of action.

Mr. Williams respectfully asks the City Council for a fair opportunity to present and execute a spot blight abatement plan and for the City to work with him throughout the renovation process. He has plans for full renovation prepared by qualified, licensed contractors. He is prepared to execute those plans, but the City has taken the position that they have lost confidence in Mr. Williams and do not trust that any proposals he makes will be completed. We believe the City's position to be unfounded, and would argue that the City is to blame for much of the delay in repairs to this Property over the last 3-4 years. It is worth noting that the City put an administrative hold on all building permit applications for this property in September of 2019. But nevertheless, my client is prepared to take actions that would render the City's fears moot, such as securing a bond to guarantee that work is completed or placing monies necessary for renovation into escrow with my law firm.

We ask the City Council to reject the Ordinance at this time and instruct the Planning Commission to allow Mr. Williams 30 days to submit an acceptable spot blight plan, and to work with Mr. Williams and his contractors in good faith to achieve and execute acceptable plan, which would include releasing any administrative holds on the issuance of the necessary permits to complete the work.

LATE PAYMENTS

The City of Richmond actively pursues payments of unpaid taxes. Payments received or postmarked after the due date are subject to a penalty of \$10 or ten percent of the taxes due (whichever is greater) and interest up to 10% per annum. Delinquent accounts may be charged a \$30 administrative fee. Failure to pay any tax obligation may result in collection action as outlined in Title 58.1 of the Code of Virginia. Unpaid taxes forwarded to a collection firm will incur additional charges up to 20% for collection fees.

LOSS OF TAX REHABILITATION CREDIT OR TAX RELIEF

Failure to pay the balance due on or before January 14, 2019 could result in the loss of your tax relief for the elderly or disabled credit. Failure to pay real estate tax balance due on or before January 14, 2019 will result in forfeiture (loss) of your tax rehabilitation credit.

Property owners 65 years of age or older, or permanently and totally disabled, may qualify for the Tax Relief for the Elderly or Disabled Program. Income and net worth limitations apply. Applications are available from the City of Richmond by calling (804) 646-7000. The deadline for first time applicants is March 31, 2019.

<u>COMPLAINT FOR DECLARATORY ACTION</u> <u>& REQUEST FOR TEMPORARY INJUNCTION</u>

COMES NOW the Plaintiff, DAVID WILLIAMS, by counsel, pursuant to Virginia Code §8.01-184 and moves this Honorable Court to make a binding determination of the rights, duties, and obligations of the parties hereto with regard to the Spot Blight Abatement Program of the City of Richmond as set forth in the Code of Ordinances of the City of Richmond §5-85 et seq. and Virginia Code §36-49.1:1 for the following reasons, to wit:

PARTIES

 The CITY OF RICHMOND is a municipal corporation in the Commonwealth of Virginia. See Code of Ordinances of the City of Richmond §1.01 et seq.

- 2. CITY OF RICHMOND CITY COUNCIL consists of nine (9) individuals elected to exercise certain powers to govern the City of Richmond as set forth in the City's Charter. *Id.*
 - 3. LEVAR STONEY is the mayor of the CITY OF RICHMOND. Id.
- 4. LENORA G. REID is/was the Chief Executive Officer of the City of Richmond at all times relevant to this Complaint. *Id*.
 - 5. CYNTHIA I. NEWBILLE is the president of CITY OF RICHMOND CITY COUNCIL.
- 6. DAVID WILLIAMS (hereinafter "Plaintiff") is the owner of certain real estate located at 1201 Porter Street in the City if Richmond, Virginia (hereinafter the "Property"), which Defendants have declared to be blighted and seek to confiscate.

PROCEDURAL HISTORY & STATEMENT OF FACTS

- 7. Plaintiff purchased the Property on or about May 23, 2002.
- 8. On March 2, 2020, Plaintiff's brother appeared on behalf of Plaintiff at City Hall and attempted to submit an application for a building permit regarding the Property. The application was not accepted and Plaintiff's brother was referred to Mark Olinger (hereinafter "Mr. Olinger"), Director of the Department of Planning & Development Review for the City of Richmond. Plaintiff's brother met with Mark Olinger in person on March 2, 2020, to discuss the building permit application. Plaintiff participated in that meeting telephonically. During that telephone call Mr. Olinger advised Plaintiff that the Property had been declared blighted by Defendants. This telephonic notification was Plaintiff's first notice that the Property was considered to be blighted by Defendants.
- 9. On March 2, 2020, after his telephonic meeting with Mr. Olinger, Plaintiff made a follow-up phone call to Mr. Olinger's assistant, Christina Thiem, who stated that she would email Plaintiff a formal notice of the spot blight determination. On March 5, 2020, Plaintiff received an email from Michelle Coward (hereinafter "Ms. Coward"), Defendants' Property Maintenance Code

Enforcement Operations Manager, with an attachment titled "Specifications of Spot Blight at 1201 Porter Street, Richmond VA – S0000087011." See Exhibit A attached hereto and incorporated herein by reference.

- 10. Defendants maintain that a formal notice was mailed to Defendant by certified mail on or about December 9, 2019, but Defendants concede that the notice was returned to them in late February 2020, because it contained the wrong zip code for Plaintiff. See the email from Mr. Olinger to Ms. Coward attached hereto as **Exhibit B** and incorporated herein by reference.
- On March 19, 2020, Plaintiff emailed a Derelict Building Work Plan to Mr. Olinger andMs. Coward. See Exhibit C attached hereto and incorporated herein by reference.
- 12. By email dated April 28, 2020, Mr. Olinger advised Plaintiff that Defendants were "planning on pursuing the blight hearing at Planning Commission on Monday May 4, 2020, at 1:30 p.m." See Exhibit D attached hereto and incorporated herein by reference.
- 13. On April 30, 2020, Plaintiff was advised in an email from Ms. Coward that it was her conclusion that the Derelict Building Work Plan that he submitted on March 19, 2020, would not be completed. See **Exhibit E** attached hereto and incorporated herein by reference.
- 14. On May 1, 2020, counsel for Plaintiff submitted a letter to Defendants alleging defective notice of process and requesting that the May 4, 2020, hearing be continued. The request for a continuance was denied and the motion was carried unanimously in the absence of Defendant and Defendant's counsel. See **Exhibit F** attached hereto and incorporated herein by reference.
- 15. On May 11, 2020, Ordinance no. 2020-124 was proposed by Defendants "to declare that a public necessity exists and to authorize the acquisition by gift, purchase, condemnation, or otherwise of the property known as 1201 Porter Street for the public purpose of implementing a Spot Blight

Abatement Plan adopted in accordance with Va. Code § 36-49.1:1 for such property." See **Exhibit G** attached hereto and incorporated herein by reference.

- 16. On May 19, 2020, counsel for Plaintiff submitted a letter to Defendants in advance of a meeting of the Department of Planning and Development Review again raising the issue of improper notice and requesting that the matter be stayed for thirty (30) days to give Plaintiff an opportunity to propose an acceptable spot blight plan. See **Exhibit H** attached hereto and incorporated herein by reference.
- 17. That Ordinance no. 2020-124 is set to be voted upon by the City of Richmond City Council at public hearing on June 8, 2020, at 6:00 p.m. If the Ordinance is adopted, then the Property will be acquired by Defendants and demolished or sold to a third party pursuant to a development agreement. See **Exhibit G** attached hereto and incorporated herein by reference.

REQUEST FOR DECLARATORY RELIEF

- 18. Paragraphs 1-17 are restated herein.
- 19. That Defendants failed to properly notify Plaintiff of the Spot Blight Abatement Plan action as required by Code of Ordinances of the City of Richmond §5-85 et seq. and/or Virginia Code §36-49.1:1. Therefore, all continuing/future action in this matter is improper.
- 20. That Defendants wrongfully rejected the work plan submitted by Plaintiff referenced in paragraph 10 herein. Therefore, all continuing/future action in this matter is improper.

REQUEST FOR TEMPORARY (PRELIMINARY) INJUNCTION

21. Paragraphs 1-20 are restated herein.

- 22. That local and state laws referenced in paragraph 18 herein require Defendants to allow Plaintiff thirty (30) days from the date of a proper notice to submit a spot blight abatement plan. Because Defendants failed to properly notify Plaintiff of the spot blight action, Plaintiff never had an opportunity to submit a spot blight abatement plan, and Defendants did not properly consider the "work plan" submitted by Plaintiff referenced in paragraph 10 herein.
- 23. Plaintiff has spent a considerable amount of money acquiring and maintaining the Property including, but not limited to, structural stabilization of the Property that was completed in or around July 2018 and passed Defendants' inspection. See **Exhibit I** attached hereto and incorporated herein by reference.
- 24. Defendants acknowledge that the building has significant historic and aesthetic value and have stated that it is Defendants' intent to renovate the Property rather than demolish it (presumably by selling it to a third party developer pursuant to a development agreement). The Property is located in an area of rapid development and revitalization and has the potential to generate significant income once renovated.
- 25. Plaintiff will suffer irreparable harm if Ordinance no. 2020-124 is adopted authorizing Defendants to confiscate Plaintiff's real property and improvements located at 1201 Porter Street in the City of Richmond. If Defendants are not enjoined from adopting the Ordinance, Plaintiff will lose *inter alia* all of the money that he has invested in the Property to date, the future income from the Property, the equity Plaintiff has accumulated in the Property and the future equity that Plaintiff expects to create through renovation of the Property.
- 26. That Defendants will not be harmed if an injunction is granted enjoining Defendants from taking any further action on the Ordinance for thirty (30) days. To date, Defendants have failed to produce any spot blight abatement plan for the Property as referenced in the Ordinance. See Exhibit G

attached hereto and incorporated herein by reference. Furthermore, the Property is stable and structurally sound as evidence by the approved stabilization plan of engineer Charles Fields that was implemented by Plaintiff and approved by Defendants in or around July 2018. See **Exhibit I** attached hereto and incorporated herein by reference.

- 27. That Plaintiff is likely to succeed on the merits because Defendants acknowledge that the address on the notice to Plaintiff of preliminary determination of spot blight required by law contained an erroneous zip code and was ultimately returned to Defendants as undeliverable. Furthermore, Orders Declaring Judicial Emergency in Response to COVID-19 issued by the Supreme Court of Virginia tolled and extended all deadlines for complying with legal notices effective March 16, 2020.
- 28. That the public interest is supported by enjoining Defendants from confiscating the Property from Plaintiff because the confiscation would violate Plaintiff's constitutional right to private property, and thereby threaten the rights of all real property owners in the City of Richmond and in the Commonwealth of Virginia.

WHEREFORE, the Plaintiff, DAVID WILLIAMS, requests that this Court determine that

Defendants failed to properly notify him that his Property was considered blighted pursuant to the Code
of Ordinances of the City of Richmond §5-118 and Virginia Code §36-49.1:1; and to determine that

Defendants failed to properly notify Plaintiff of the specific reasons why the property was considered
blighted as required by Code of Ordinances of the City of Richmond §5-118 and Virginia Code §3649.1:1; and to determine that Defendants failed to properly accept, review and consider the work plan
that was submitted by Plaintiff; and to order that the pending spot blight abatement action(s) by

Defendants to acquire the Property be stayed and/or terminated in order to allow Plaintiff the

opportunity to submit and execute an acceptable spot blight abatement plan; and to order Defendants to properly consider any such spot blight abatement plan(s) submitted by Plaintiff; and for such other and further relief as the Court may deem equitable and just under the circumstances of the case at bar.



This property in its current condition is a continuing threat to public health, safety and welfare. The current conditions of the building do not meet the Commonwealth of Virginia, Part III of the Virginia Uniform Statewide Building Code, The Virginia Maintenance Code (2015) edition as amended and adopted by the City of Richmond per Code Section 5-1. The property exhibits neglect and decay in its present condition and is causing a significant blighting influence on the community.

Current conditions and violations include the following:

- This structure has been vacant since 1997.
- Utilities have been disconnected from the structure since 1997.
- Ownership of the property is listed at an address that indicates the owner does not live there.
- The owner has made application for building permits on several occasion but has never had the permits inspected for compliance.
- The property has been in the Derelict Building Program since 2016 and although the owner is aware of this, no effort has been made to come into compliance.
- This property has been abated by use of City Contractors on three different occasions.
- Chimney in rear has collapsed.
- Extensive roof damage allowing water to infiltrate into the structure.
- Rotten headers.
- Mortar is loose and falling out of the joints.
- Cornices are rotten and falling away from the building.
- Interior of structure has sustained long-term weather exposure.
- Windows and doors are missing from the structure.



I represent David Williams with regard to pending actions by the City of Richmond regarding the real property and improvements located at 1201 Porter Street in the City of Richmond (the "Property"). It is my understanding that the Land Use, Housing and Transportation Standing Committee will be considering an action on the Property in their meeting at 1:00pm today. Please read this correspondence into the record and make it a formal part thereof.

It is my client's position that he was not provided proper notice as required by Virginia Code §36-27(B). Specifically, it is my understanding from emails between Mr. Olinger and Ms. Coward on or about March 2, 2020, that the City sent correspondence to my client using an erroneous zip code.

There was some confusion at the May 4, 2020, spot blight hearing when Ms. Coward testified that my client proposed an 18 month work plan. The work plan she referenced was for a full renovation of the Property pursuant to the derelict building program. It was not a spot blight abatement plan. My client did not submit a spot blight abatement plan because he was never properly notified of the spot blight action as stated above. However, my client is willing and able to abate the blight within 6 months and subsequently renovate the Property in conjunction with the appropriate authorities in order to bring it into compliance with the City code. I respectfully request that this matter be stayed and that my client be given 30 days to propose an acceptable spot blight abatement plan, which he understands should be completed within 6 months.


