## Call to Order

Chair Ellen Robertson called the meeting to order at 1:07 p.m., and presided.

#### **Electronic Participation**

Assistant City Clerk Pamela Nichols, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, announced the meeting would be held through electronic communication means. Assistant City Clerk Nichols stated notice of the meeting was provided to the public through a public information advisory issued on July 14, 2020, and through Legistar on the city website in accordance with usual practice. #### The following ordinance was considered:

<u>ORD. 2020-152</u> To designate the 4000, 4100, 4200, and 4300 blocks of Crutchfield Street in honor of the late Leslie D. Jackson. **Patron:** Ms. Lynch

Councilor Stephanie Lynch introduced ORD. 2020-152.

There were no further comments or discussions and Vice Chair Kim Gray moved to forward ORD. 2020-152 to Council with the recommendation to approve, which was seconded and unanimously approved.

#### The following ordinance was considered:

#### ORD. 2020-153

To rename that portion of U.S. Route 1, known as Jefferson Davis Highway and located within the corporate boundaries of the City, from its northerly terminus at its intersection with Hull Street to its southerly terminus at the corporate limits of the City near its intersection with Walmsley Boulevard, as "Richmond Highway."

Patron: Ms. Trammell

Citizens were provided an opportunity to offer comments in writing regarding this legislation prior to the committee meeting. All written comments received by the Office of the City Clerk were provided to members of the committee and are included as an Appendix to the July 21, 2020 Land Use, Housing and Transportation meeting minutes.

# Public Hearing

*Free Bangura, History and Culture Commission chair*, advised the committee that the History and Culture Commission would like to provide assistance in a public forum for renaming Jefferson Davis Highway.

### Councilor Stephanie Lynch exited the meeting.

*Megan Rickman Blackwood* expressed support of the renaming of Jefferson Davis Highway but expressed concern that the public was not afforded an opportunity to participate in the process. Ms. Blackwood asked the committee to amend ORD. 2020-153 to require public input.

*Bryan Green* expressed support of ORD. 2020-153 and stated he also looked forward to renaming public buildings and streets which would more accurately reflect the diverse history of the city.

**Ron Moore** stated he opposed the use of funds to rename Jefferson Davis Highway. He stated the money could be better served to provide support for low income communities or to bring to justice individuals who caused destruction within the city during recent protests.

Member Michael Jones stated he supported the renaming of Jefferson Davis Highway; however, he stated there should be public input on an appropriate name.

Vice Chair Kim Gray stated she was comfortable forwarding ORD. 2020-153 to Council with an amendment which would require public input on the renaming, and to allow the History and Culture Commission to take part in the process.

Bonnie Ashley, deputy city attorney, provided two options for the committee to consider regarding ORD. 2020-153.

Lincoln Sanders, Office of the Mayor chief of staff, remarked that ORD. 2020-153 was similar to the request to rename the Robert E. Lee Memorial Bridge; he asked that the History and Culture Commission be able conduct public engagement prior to Council's consideration of the proposed legislation.

Member Jones stated that the paper should be continued to allow for both an amendment and the commission to conduct its public engagement prior to consideration by Council.

There were no further comments or discussions and **Member Michael Jones moved to** continue ORD. 2020-153 to the September 22, 2020 Land Use, Housing and Transportation Standing Committee meeting, which was seconded and unanimously approved.

#### The following ordinance was considered:

#### ORD. 2020-154

To provide for the removal of certain monuments on City-owned property, provide for the disposition of such monuments, and repeal an ordinance accepting the General Thomas J. "Stonewall" Jackson monument, adopted Mar. 3, 1920, as authorized by Va. Code § 15.2-1812. **Patron:** Mr. Jones, Ms. Lynch, Mr. Addison, Vice President Hilbert, President Newbille, Ms. Gray, Ms. Larson and Ms. Robertson

Citizens were provided an opportunity to offer comments in writing regarding this legislation prior to the committee meeting. All written comments received by the Office of the City Clerk were provided to members of the committee and are included as an Appendix to the July 21, 2020 Land Use, Housing and Transportation meeting minutes.

*Free Bangura, History and Culture Commission chair*, stated that billions of dollars were spent in Virginia on heritage tourism and the pedestals which held the confederate statues should be resurfaced and repurposed to reflect the future of the city.

*Megan Rickman Blackwood* expressed support of ORD. 2020-154. She stated the pedestals represent change in the city and she hoped the pedestals would not be destroyed but offered to interested parties.

**Ron Moore** stated the Code of Virginia prohibits the destruction and alteration of statues, and the City Charter requires removal of statues to be reviewed by the Commission of Architectural Review. He further stated the July 1<sup>st</sup> removal of the statues was unlawful and the contractual agreement regarding General Thomas J. "Stonewall" Jackson monument was binding and could not be repealed.

Bonnie Ashley, deputy city attorney, stated the proposed legislation was pursuant to provisions in the Code of Virginia which granted localities the ability to remove certain statues and the pedestals from city-owned properties.

There were no further comments or discussions and **Member Michael Jones moved to forward** ORD. 2020-154 to Council with the recommendation to approve, which was seconded and unanimously approved.

### The following resolution was considered:

#### RES. 2020-R044

To express the Council's support for the Director of Public Works' administrative directive entitled "Protected walkways and crosswalks, bicycle lane, and shared use paths" requiring certain pedestrian and bicycle accommodations and pathways within construction work zones. **Patron:** Mr. Addison and Mr. Jones

Citizens were provided an opportunity to offer comments in writing regarding this legislation prior to the committee meeting. All written comments received by the Office of the City Clerk were provided to members of the committee and are included as an Appendix to the July 21, 2020 Land Use, Housing and Transportation meeting minutes.

Councilor Andreas Addison introduced RES. 2020-R044.

There were no further comments or discussions and Vice Chair Kim Gray moved to forward RES. 2020-R044 to Council with the recommendation to approve, which was seconded and unanimously approved.

Councilor Andreas Addison exited the meeting at 2:13 p.m.

## **Discussion Item**

Julie Timm, Greater Richmond Transit Company (GRTC) chief executive officer, acknowledged that GRTC Board of Directors Chair Benjamin Campbell and GRTC Communications Director Carrie Rose Pace were present to respond to questions. Ms. Timm presented an update on the impact of the civic protests on GRTC service, COVID-19 response and service impacts, GRTC's operational budget, and the downtown transfer center. Ms. Timm reported GRTC seeks support from the city for the formation of a task force to engage the community on potential plans for a permanent transfer station.

A copy of the material provided has been filed.

The committee asked questions regarding the impact on GRTC's budget for the replacement of the bus destroyed during the civil unrest, the waving of bus fares and the company's FY 2021 budget gap. The committee also asked that the presentation be sent to all members of Council.

Chair Ellen Robertson asked committee members and city administration to provide responses and recommendations regarding the topics of discussion provided by Ms. Timm.

# Staff Report

Steve Taylor, council policy analyst, and Bill Echelberger, council budget analyst, provided the committee with the July staff report.
