GREATER RICHMOND CONTINUUM OF CARE NON-CONGREGATE SHELTER: PROGRAM REPORT & OUTCOMES

- 1. Since mid-March Homeward has operated the Greater Richmond Region's Pandemic Response Non-congregate Shelter Program.
- 2. Homeward has followed CDC and HUD guidelines to expand the immediate pandemic response to identify non-congregate shelter and provide support to those who are experiencing homelessness and are at risk for COVID- 19.
- 3. The GRCoC's program is part of a coordinated, collaborative pandemic response to expand emergency shelter capacity to meet the needs of persons experiencing homelessness and to strengthen service coordination and referral mechanisms between homeless services and public health.
- 4. The Pandemic Response Shelter Program allows for existing GRCoC shelters to operate at a reduced capacity, thereby adhering to CDC social distancing guidelines. Additionally, the program has the unique attribute of expandable capacity, allowing for an increase in available units when shelter demand increases during extreme weather.















PROGRAM OUTCOMES & LENGTHS OF STAY

NEXT STEPS:

- 1. Collaborative planning with 10 homeless service providers and other GRCoC stakeholders to address the increased needs of people experiencing homelessness during the winter months.
- 2. Continuing to provide safe, indoor accommodations to those at greatest risk from COVID-19.
- 3. Increase in housing supports through Rapid Re-housing and housing-focused case management.
- 4. Development of a cross-sector safety net response plan for severe threats to public health and safety due to weather emergencies.
