To Whom It May Concern:

I ask that you support the expansion of Community Alternatives Consortium so that they may continue their mission to serve an underserved and disenfranchised population. Maintaining housing and independent living is a constant struggle for those experiencing mental illness in lower-income, urban areas. Working in this field, I can attest that most members of the seriously mentally ill (SMI) population have difficulties with developing and implementing the skills necessary to financially, physically, and emotionally care for themselves on a long-term basis due to their symptomology. They have often alienated or confounded their natural support systems over time and are left homeless. Since the deinstitutionalization of state facilities, our community has observed a dramatic increase of the phenomena referred to by many as the "walking mad" (i.e., those with mental illness so severe they cannot care for themselves, have no supports, have no housing nor any way to go about obtaining or maintaining it living on the streets). From a theoretical paradigm regarding a person's hierarchy of needs, we cannot begin to tackle some of the more complex issues such as mental illness symptoms and social functioning if an individual's basic needs (shelter, food, etc.) are not being met.

There are some assisted living facilities that have sprung up in the Richmond area to try to meet the needs of this population, but they are generally either geared towards or, just by happenstance, house only older adults so that younger individuals are not eligible, not accepted, or further estranged. There are so few options for younger individuals suffering from mental illness who have different needs specific to their cohort, such as having to be rehoused for the first time to somewhere other than the home they were raised in, being new to their mental illness since the age of onset for many SMI's are prior to age 25, and not fully understanding the impact these symptoms have on their daily living. Community Alternatives Consortium has been providing assisted living services with satisfactory efficacy to this identified population for years, which has benefitted all stakeholders in the area including the individuals themselves, mental health professionals, law enforcement, and the community as a whole. They have been a vital community-based resource and have provided younger adults with assisted living that both promotes independence and provides support when necessary in a least restrictive environment.

I have an adult son with a severe mental illness that requires supervision and care coordinated with the affiliated community service board. He has been struggling with his illness for 14 years.

Over the course of time he has resided in Totty House in Ettrick, VA, Gateway Homes in Chesterfield, VA and recently CAC in Chesterfield and Richmond locations. Due to the nature of his illness he has required hospitalization on many occasions. There is a tremendous need for proper housing and constructive programs to support this population. It's very important that family can be close by to support and intervene when necessary.

It has been a difficult task to find housing in a nurturing environment and close to support systems including family, mental health professionals, laboratory and medical care.

I highly recommend Community Alternatives Consortium for providing this level of care. They show concern, offer support to the residents including outings and encourage participation in day programs and rehabilitation. Please give serious consideration to this request. Most of the existing facilities do not offer services to this age group (18-45) or prohibit persons with mental illness history.
