WHEREAS, the Council believes that it is in the best interests of the citizens of the City of Richmond that the street located in the city of Richmond and known as Confederate Avenue

be renamed as "Laburnum Park Boulevard" without the necessity for strict compliance with the

requirements set forth in sections 8-7 through 8-10 of the Code of the City of Richmond (2015),

as amended;

NOW, THEREFORE,

THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That, notwithstanding the provisions of sections 8-7 through 8-10 of the Code of

the City of Richmond (2015), as amended, or any other law to the contrary, the street located in

the city of Richmond and known as "Confederate Avenue" be and is hereby renamed as

"Laburnum Park Boulevard."

§ 2. That, in order to effectuate the provisions of section 1 of this ordinance, the Chief

Administrative Officer shall (i) cause the appropriate City agency to prepare and erect signs

appropriately marking "Laburnum Park Boulevard," (ii) request that all City agencies note such

renaming in the records maintained by each such agency, and (iii) take all other appropriate

actions to effectuate the renaming of Confederate Avenue as "Laburnum Park Boulevard."

§ 3. This ordinance shall be in force and effect upon adoption.

ORDINANCE/RESOLUTION SUMMARY

The patron requests an ordinance to rename Confederate Avenue as Laburnum Park Avenue.

- The requested ordinance shall be effective upon passage.
- The Department of Public Works shall make such signage changes as are appropriate to reflect the new name as soon as practical.

BACKGROUND

Summary:

- Confederate Avenue is named for the Confederate States of America.
- The patrons believe that the name change is a positive unifying action that is reflective of all Richmonders.
- Confederate Avenue consists of 62 households within four blocks bordered by Brook and Hermitage Roads.
- In March 2019 a committee was formed to evaluate and pursue a name change.

- Among other outreach efforts, the committee undertook two surveys:
 - Survey #1: 75% of all households and 85% of those who voted expressed support for changing the name of the street. Note: 2 houses are vacant: 1603, 1609
 - Survey #2: With a 90% participation rate on a ranked choice voting survey of 11 proposed street names, the top 1st, 2nd and 3rd choice winner was Laburnum Park Boulevard.

Confederate Avenue Street Name Change: Neighborhood Process

Confederate Avenue consists of 62 households within four blocks bordered by Brook and Hermitage Roads. Over the years, many residents have informally discussed the possibility of changing the street name to something more welcoming and inclusive. This effort became more organized in March 2019, when a committee formed to evaluate and pursue a name change. Each block is represented on this committee. In addition to committee work, block representatives have participated in separate block meetings and face-to-face conversations to engage and inform neighbors about the project and process. This included direct outreach to households who opposed a name change and/or who criticized the committee's work. In addition, block representatives followed up with neighbors who did not participate in the surveys and those not comfortable with responding online. Over the entire period, with several flyers distributed streetwide, along with two distinct surveys of the entire street, the committee encouraged feedback from everyone.

The survey results show the following:

<u>Survey #1, dated June 16, 2020</u> – **75% of all households** (45 out of 60 families) and **85% of those who voted** (45 out of 52) support changing the name of the street. *Note: 2 houses are vacant:* 1603, 1609

<u>Survey #2 dated July 6, 2020</u> – With a **90% participation rate** (56 out of 62 households) on a ranked choice voting survey of 11 proposed street names, the top 1st, 2nd and 3rd choice winner is Laburnum Park Boulevard, recognizing the prominence of our street as a central boulevard in the Laburnum Park Historic District.

These survey results demonstrate strong, street-wide support to change the name of Confederate Avenue. Thus, we respectfully request that our Council representatives, the Honorable Kimberly Gray and the Honorable Chris Hilbert, sponsor an ordinance to legally change the street name from Confederate Avenue to <u>Laburnum Park Boulevard</u>.

DISCUSSION OF NAME-CHANGE FOR CONFEDERATE AVE

NEXT STEP: BLOCK CONVERSATIONS

Between now and August 23rd, connect with neighbors in your block to gauge the level of support about changing the name of our street. Reps from each block are encouraged to decide how that connection will happen (e.g., door to door conversations, block meeting, coffee...)

Set up the conversation in whatever way is most natural and comfortable for you. Ideas re: openers include:

- In other cities throughout the country, neighborhoods are changing the names of streets that have honored the confederacy to more welcoming, inclusive names. (Last year Austin changed its Jeff Davis Ave and Robert E. Lee Road; this year Atlanta changed its Confederate Ave to United Ave.)
- Over the years, a number of neighbors have had conversations about changing our street name. There is new enthusiasm for moving the conversation forward, and we are educating ourselves about the required process. But Step #1 is learning about neighbors' questions, concerns, and opinions about a name change.
- Share any personal experiences, feelings you might have had over the years about the street name and mention discomforts expressed by neighbors at our initial meeting.

Here are the key talking points that we all agreed to at the 7/16 meeting:

- 1. I/we would really value hearing your thoughts about a street name change.
- 2. What are some questions and/or concerns you think folks might have?
- 3. If a majority of neighbors agree to changing the name, what suggestions do you have? Note: If asked, here are some names others have suggested:

Community Ave; Median Ave; Hydrangea Ave; United Ave; Unity Ave; Walton Ave;

4. May we have your email address/phone number to keep you informed? Are you interested in being more directly involved?

FYI for us: As currently understood, here is the Post Office street name change process:

- The City of Richmond will notify the USPS of the street name change.
- The USPS Address Management Department will make the system change within 7 days of receipt of change.
- We would continue to receive mail addressed to Confederate Ave for possibly indefinitely. It is best to contact family, friends, banks etc with the new street name change when finalized.

CONFEDERATE AVE NAME CHANGE EFFORT INFORMATION AND STATUS UPDATE

Background

In other cities throughout the country, neighborhoods are changing the names of streets that have honored the Confederacy to more welcoming, inclusive names. (Last year Austin changed its Jeff Davis Avenue and Robert E, Lee Road; this year Atlanta changed its Confederate Ave. to United Ave. And, in May of this year Arlington County, Virginia changed the name of its Jeff Davis Highway [Route 1] to Richmond Highway.)

Over the years, many Confederate Avenue neighbors have discussed the possibility of changing our street name. There is new momentum for moving the process forward. Starting last summer, a small group of neighbors -- representing each of the 4 blocks of the street -- met several times to learn about the required process. We have also engaged neighbors in conversations to learn about their questions, concerns, and opinions about a name change. We've heard a wide range of opinions - from enthusiastic support to strong opposition.

We live in the Laburnum Park Historic District. And, in honoring that, we have gained a deeper understanding of our neighborhood from local historians as well as our own research about the naming of some of the street names in our community:

Laburnum Park was a development led by the descendants of Joseph Bryan - the original owner of the Laburnum House. Thus, many of the street names in our community have an association with the Bryan family: Lamont was the maiden name of Joseph Bryan's wife Isobel; Chatham was the historic home of Betty Coalter Bryan, Joseph's mother: Wilmington Island, Georgia was the site of a family home in the late 18th and early 19th centuries; and, Palmyra, Virginia is where Bryan first practiced law. Confederate, the only name that doesn't refer to a person or place may have been inspired by the family's strong commitment to the Confederate cause. Joseph Bryan took up arms for the Confederacy (the Confederate States of America) at the age of 18 and fought with the Richmond Howitzers and the Mosby's Rangers. His wife Isobel founded the Confederate Memorial Literary Society which became the Museum of the Confederacy.

In conversations with our Council Representatives as well as with city staff, it's required that we offer a new name to replace the current one. Thus far, the top suggestions for new names have been.

- "Walton Ave" which would just extend the street name from the east side of Brook Rd.
- "Median Way" which acknowledges the beautiful wide avenue and grass median for mature trees.

Support and opposition rationale are summarized below.

Support for a Name Change

- After 154 years, it is no longer necessary or appropriate to continue to honor the Confederacy's divisive purposes and support of slavery.
- Supporters have often been embarrassed and/or applogetic about the name, and some of their children have been ridiculed when telling friends and classmates their address.
- The history of the area is still preserved by the historical marker on Brook Road at Confederate
 Avenue and several displays of cannon balls and other remnants of the Civil War on various
 properties. While other streets in the area may have derivations from individuals or battle sites
 from the Civil War (including Walton), those names do not directly draw attention to support for
 the Confederacy.
- People who are "okay" with the name have also said that if it is offensive to others on the street, they would support a change.

- When we individually and collectively make intentional efforts to remove daily reminders of our exclusive and divisive history, then we will fully realize the grandeur of our community.
- And, while changing our addresses will create some minimal inconveniences for everyone, the
 goal of a new street name is forward looking i.e. to secure a more hospitable, inclusive and
 welcoming neighborhood for future generations.

Opposition to a Name Change

- Opponents say the name remains historically relevant and there is no need or reason to change it, It is based on the historic significance of the street which served as the outer fortifications of the Confederate Army to protect Richmond during the Civil War.
- The current name is "no big deal" and Confederate is "just a name" and it affects nothing, ultimately.
- Many neighbors have cited a "hassle factor". They are concerned that a name change will require immediate address changes for their home businesses, mail, countless records and other arrangements. [Note: The U.S. Postal Service confirms that, after a street name change, mail delivery and services will continue to the previous street name far into the future, sometimes as long as 10 years! Likewise, individual actions to shift to the new name can occur over a very long period of time.]

Next.Steps

- We'd like to hear back from you with questions, information additions, other street name suggestions, etc. by the end of this year.
- We plan to send out an updated information sheet the la of the year.
- When that updated information sheet is disseminated, it will also include a postcard for each household to formally vote on their support or opposition to the name change as well as a proposed new name.

In December, 2019 we communicated with all the households on the street about ongoing conversations and efforts to change our street name to a more welcoming one. Thank you for your questions, feedback and follow up conversations about your support, opposition and even suggestions for another name.

When the Covid-19 pandemic disrupted our lives, we paused. Recent events have moved a number of neighbors to express a desire to revive and move forward <u>now</u>. The local – and worldwide – movement to address a series of recent brutal and inhumane killings of Black Americans and tackle long-standing racial injustice and disparities demand our attention now more than ever. THANK YOU to all of the households (52 out of 59!) for sharing your feedback on our latest survey. We want to share the results and the next steps. Our goal is to be transparent, open-minded, and collaborative - in the spirit of our neighborhood.

Survey Results

An overwhelming majority (76% of all households – 45 out of 59 families) on our street indicated that they support changing the name of the street. *Note: 3 houses are vacant: 1603, 1609 and 1512.* We sincerely value your feedback and participation.

Our Next Steps: The Naming Process

We received significant feedback about the new street name process. To promote broad understanding and full participation, we have revised the naming process.

- 1. By Tuesday, July 7th you will receive a link to another online survey.

Every suggested name was reviewed for viability using the <u>Street Name Clearinghouse</u> reference tool, which is maintained by PlanRVA (formerly Richmond Regional Planning District Commission). From the PlanRVA website:

The Intent of this region-wide tool is to avoid and eliminate, whenever possible, existing street name duplicates. With the implementation of the E-911 system for Emergency Responders (Charles City, Chesterfield, Hanover, Henrico, Goochland, New Kent, Powhatan, Richmond) avoiding duplication is important in preventing potential delays in emergency service response. There is an additional benefit in reducing confusion related to public and private delivery services and costs. The Street Name Clearinghouse (SNC) program is advisory only. Following the recommendations is at the prerogative of each local government.

Not all of the suggested names proved to be unique to the region or to Richmond specifically. These names are no longer in contention because similar names are already in use or are reserved for use as noted in the table below.

City Street Name Changing Process

- Once we have decided on a name, we will submit documentation of our process and our preferred new name to our City Council reps: Kim Gray, 2nd District and Chris Hilbert, 3rd District. (Their preference before making a resolution is that at least 67% of the households support the name change.)
- City Council Representatives will introduce a joint resolution to Council on either the 2nd or 4th Monday at a Council meeting.
- The Chief Administrative Officer (CAO) shall prepare a report to submit to Council that includes reviews by Public Works for estimated costs as well as by the Transportation, Land Use and Housing Committee. Note: Any costs incurred for the change will be absorbed by the City.
- 4. The Report is submitted to Council which then holds a public hearing before taking final action.
- Once the resolution has been passed, City Administration will implement the resolution inclusive of notifying all city departments as well as other entities (Post Office, Mapping, etc.) of the change.

Thank you to all of our neighbors for submitting your votes for the name change of our street. We had 90% participation! 56 out of 62 households voted - a great turnout! We appreciate everybody taking the time to express your preferences and make your vote count.

Here's a brief summary of the results. You can find pie charts with the votes for all candidates on the following page.

First Preference

Laburnum Park Boulevard - 50% Grace Arents Avenue - 23.2% Verdant Avenue - 8.9%

Second Preference

Laburnum Park Boulevard - 41.1% Grace Arents Avenue - 26.8% Verdant Avenue - 14.3%

Third Preference

Laburnum Park Boulevard - 35.7% Grace Arents Avenue - 23.2% Verdant Avenue - 14.3%

You may also vote for a single preferred name three times (as your #1, #2 and #3 choices). Voting multiple times for a single candidate indicates your strong preference for one option, while selecting three different candidates indicates your interest in several names as good candidates. 
Based on these results, we see that Laburnum Park Boulevard received the most votes by a substantial margin for first preference. Receiving half of the first preference votes means it received as many votes as all other candidates combined. Residents also indicated it as a strong preference since it also received the most second- and third-preference votes. Grace Arents Ave. was the second highest vote getter and Verdant Ave. placed third.

Our next step will be to submit these results and our neighborhood's preference for Laburnum Park Boulevard to our City Council representatives who then will make a joint resolution to City Council to officially change our street name. The City will also conduct its own due diligence procedures to ascertain the utility of a proposed name.


