### ORDINANCE/RESOLUTION SUMMARY

Patron requests that legislation be drafted imposing enhanced speeding penalties on Harrison and Colorado Streets between the intersections with Idlewood and S. Allen Avenues, in accordance with Va. Code § 46.2-878.2 and City Code § 102-188 and authorizing appropriate signage to give the public notice of the enhanced penalties.

# BACKGROUND

Traffic calming studies were conducted in the City along Harrison and Colorado Streets and the intersections with Idlewood and S. Allen Avenues. These studies found that the speed and volume justified enhanced penalties for speeding along Harrison and Colorado Streets between their intersections with Colorado Avenue and S. Allen Avenue. The study found

that vehicles frequently travel above the posted speed limit of 25 mph in the area. Signage is necessary to reflect the enhanced penalty.
