

The Task Force shall consist of nine residents of the city of Richmond appointed by the Council. All appointments shall be otherwise governed by sections 2-755 and 2-756 of the Code of the City of Richmond (2015), as amended.

The membership of the Task Force should possess a broad range of experience with expertise in policy development, legal, racial, and social justice advocacy, criminal justice education, or human resources. Of the nine members,

(i) at least one member shall be a youth age 18 or younger,

(ii) at least one member shall be a resident of public housing, and

(iii) at least one member shall be a person with a disability.

The Task Force shall submit to the Council a status report on the progress towards the completion of the Task Force's duties set forth in Ordinance No. 2020-155 by no later than January 4, 2021. The Task Force shall submit to the Council a final written report, containing the Task Force's reviews and recommendations concerning the creation of a Civilian Review Board, including a proposed annual budget for any Civilian Review Board that the Task Force may recommend, by no later than March 1, 2021.

This spring, we collaborated with the VMFA to hold our final class--focusing on Virginia hip hop--at the VMFA itself, making it free and open to the community. COVID scrambled those plans, but we are already looking at something similar for next spring.


