WHEREAS, the owner of the property known as 1110 ½ North 30<sup>th</sup> Street, which is situated in a R-6 Single-Family Attached Residential District, desires to use such property for the purpose of a two-family detached dwelling, which use, among other things, is not currently allowed by section 30-412.4, concerning lot area and width, density, and unit width, of the Code of the City of Richmond (2015), as amended; and

WHEREAS, in accordance with section 17.11 of the Charter of the City of Richmond (2020), as amended, it has been made to appear that, if granted subject to the terms and conditions set forth in this ordinance, the special use granted by this ordinance will not be detrimental to the

safety, health, morals and general welfare of the community involved, will not tend to create congestion in streets, roads, alleys and other public ways and places in the area involved, will not create hazards from fire, panic or other dangers, will not tend to overcrowding of land and cause an undue concentration of population, will not adversely affect or interfere with public or private schools, parks, playgrounds, water supplies, sewage disposal, transportation or other public requirements, conveniences and improvements, and will not interfere with adequate light and air; and

WHEREAS, (i) the City Planning Commission has conducted a public hearing to investigate the circumstances and conditions upon which the Council is empowered to authorize such use, (ii) the City Planning Commission has reported to the Council the results of such public hearing and investigation and its recommendations with respect thereto, and (iii) the Council has conducted a public hearing on this ordinance at which the person in interest and all other persons have had an opportunity to be heard;

NOW, THEREFORE,

THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. **Finding.** Pursuant to section 30-1050.1 of the Code of the City of Richmond (2015), as amended, the Council hereby finds that the special use set forth in and subject to the terms and conditions of this ordinance will not (i) be detrimental to the safety, health, morals and general welfare of the community involved, (ii) tend to create congestion in streets, roads, alleys and other public ways and places in the area involved, (iii) create hazards from fire, panic or other dangers, (iv) tend to overcrowding of land and cause an undue concentration of population, (v) adversely affect or interfere with public or private schools, parks, playgrounds, water supplies, sewage disposal, transportation or other public requirements, conveniences and improvements, or

(vi) interfere with adequate light and air.

**§ 2. Grant of Special Use Permit.**

(a) Subject to the terms and conditions set forth in this ordinance, the property known as 1110 ½ North 30<sup>th</sup> Street and identified as Tax Parcel No. E000-0568/012 in the 2020 records of the City Assessor, being more particularly shown on a survey entitled “Survey and Plat of The Property Known as #1110 N. 30<sup>th</sup> Street in the City of Richmond, VA,” prepared by Edwards, Kretz, Lohr & Associates, PLLC, and dated December 27, 2019, a copy of which is attached to and made a part of this ordinance, hereinafter referred to as “the Property,” is hereby permitted to be used for the purpose of a two-family detached dwelling, substantially as shown on the plans entitled “New 2-Story Duplex, 1110 ½ N. 30<sup>th</sup> Street, Richmond, Virginia,” prepared by Michael Pellis Architecture, and dated April 28, 2020, hereinafter referred to as “the Plans,” copies of which are attached to and made a part of this ordinance.

(b) The adoption of this ordinance shall constitute the issuance of a special use permit for the Property. The special use permit shall inure to the benefit of the owner or owners of the fee simple title to the Property as of the date on which this ordinance is adopted and their successors in fee simple title, all of which are hereinafter referred to as “the Owner.” The conditions contained in this ordinance shall be binding on the Owner.

**§ 3. Special Terms and Conditions.** This special use permit is conditioned on the following special terms and conditions:

(a) The Special Use of the Property shall be as a two-family detached dwelling, substantially as shown on the Plans.

(b) The height of the Special Use shall not exceed the height as shown on the Plans.

(c) All building materials and elevations for the Special Use shall be substantially as shown on the Plans.

(d) All mechanical equipment serving the Property shall be located or screened so as not to be visible from any public right-of-way.

(e) A minimum of two off-street parking spaces shall be provided on the Property, substantially as shown on the Plans.

**§ 4. Supplemental Terms and Conditions.** This special use permit is conditioned on the following supplemental terms and conditions:

(a) All required final grading and drainage plans, together with all easements made necessary by such plans, must be approved by the Director of Public Utilities prior to the issuance of the building permit.

(b) Storm or surface water shall not be allowed to accumulate on the land. The Owner, at its sole cost and expense, shall provide and maintain at all times adequate facilities for the drainage of storm or surface water from the Property so as not to adversely affect or damage any other property or public streets and the use thereof.

(c) Facilities for the collection of refuse shall be provided in accordance with the requirements of the Director of Public Works. Such facilities shall be located or screened so as not to be visible from adjacent properties and public streets.

(d) Any encroachments existing, proposed on the Plans or contemplated in the future shall require separate authorization and shall be subject to the applicable provisions of the Code of the City of Richmond (2015), as amended, and all future amendments to such laws.

(e) In all other respects, the use of the Property shall be in accordance with the applicable underlying zoning regulations.

**§ 5. General Terms and Conditions.** This special use permit is conditioned on the following general terms and conditions:

(a) No permit implementing this special use permit shall be approved until satisfactory evidence has been presented to the Zoning Administrator that any delinquent real estate taxes applicable to the Property have been paid.

(b) The Owner shall be bound by, shall observe and shall comply with all other laws, ordinances, rules and regulations applicable to the Property, except as otherwise expressly provided in this ordinance.

(c) Words and phrases used in this ordinance shall be interpreted to have the meanings ascribed to them by section 30-1220 of the Code of the City of Richmond (2015), as amended, unless the context clearly indicates that a different meaning is intended.

(d) Notwithstanding any other provision of law, this special use permit is being approved due, in part, to the mitigating effects of each and every condition attached hereto; consequently, if any portion of this ordinance is determined to be invalid for any reason by a final, non-appealable order of any Virginia or federal court of competent jurisdiction, the invalidity shall cause the entire ordinance to be void and of no further effect from the effective date of such order.

(e) The privileges granted by this ordinance may be revoked pursuant to the provisions of sections 30-1050.7 through 30-1050.11 of the Code of the City of Richmond (2015), as amended, and all future amendments to such laws. Failure to comply with the terms and conditions of this ordinance shall constitute a violation of section 30-1080 of the Code of the City of Richmond (2015), as amended, and all future amendments to such law, or any other applicable laws or regulations.


(f) When the privileges granted by this ordinance terminate and the special use permit granted hereby becomes null and void, whether as a result of the Owner relinquishing this special use permit in a writing addressed to the Director of Planning and Development Review or otherwise, use of the Property shall be governed thereafter by the zoning regulations prescribed for the district in which the Property is then situated.

§ 6. **Implementation.** The Commissioner of Buildings is authorized to issue a building permit substantially in accordance with the Plans for the Special Use subject to the terms and conditions set forth in this ordinance. An application for the building permit shall be made within 730 calendar days following the date on which this ordinance becomes effective. If either the application for the building permit is not made with the time period stated in the previous sentence or the building permit terminates under any provision of the Virginia Statewide Building Code, this ordinance and the special use permit granted hereby shall terminate and become null and void.

§ 7. **Effective Date.** This ordinance shall be in force and effect upon adoption.



No.** \_\_\_\_\_**PURPOSE:** To authorize the special use of the property known as 1110 1/2 North 30th Street for the purpose of a two-family detached dwelling upon certain terms and conditions.**REASON:** The subject property is located in the R-6 Single-Family Attached Residential District. Two-family detached dwellings are a permitted use in this zoning district provided that the subject property meets certain lot feature requirements. The subject property does not meet these lot feature requirements therefore a special use permit is required.**RECOMMENDATION:** In accordance with the requirements of the City Charter and the Zoning Ordinance, the City Planning Commission will review this request and make a recommendation to City Council. This item will be scheduled for consideration by the Commission at its December 7, 2020, meeting.**BACKGROUND:** The zoning ordinance allows two-family detached structures in R-6 Single-Family Attached Residential District on parcels that provide at least 6,000 square feet of area and 50 feet of street frontage. The subject property is a vacant parcel of land with 3,300 square feet of area. The street frontage is 25 feet in width and the depth is 132 feet. The proposed structure provides front, rear and side yard setbacks as required in the zoning ordinance.

The property is located near the corner of North 30th Street and Q Street. An alley provides access from the rear. It is located in the Church Hill North Neighborhood within the City's East Planning District. The City of Richmond's Master Plan designates the subject property for Single-Family (Medium Density) uses. Primary uses are single-family and two-family dwellings, both detached and attached, at densities of 8 to 20 units per acre. The net density of the proposed development is approximately 26 units per acre.

## Introduction

The property owner is requesting a special use permit ("SUP") for 1110.5 North 30<sup>th</sup> Street (the "Property"). The SUP would authorize the construction of a two-family detached dwelling. The lot width and lot area do not conform to the underlying R-6 Single-Family Attached Residential district zoning requirements applicable to the Property under this proposal.

## Existing Conditions

### SITE DESCRIPTION AND EXISTING LAND USE

The Property is located on the western side of North 30<sup>th</sup> Street between Q Street and R Street, and is referenced by the City Assessor as tax parcel F000-0568 012. The Property is a vacant lot that is roughly 25' wide by 132' in depth and contains approximately 3,300 square feet of lot area. The lot is relatively flat and is afforded access in the rear by means of a north-south alley running parallel to North 30<sup>th</sup> Street.



The properties on the block are generally developed with single family detached dwellings or are undeveloped vacant lots. To the south, the property at 2910 Q Street is currently being developed with a mixed-use building, which will have 13 dwelling units and 1,214 square feet of commercial space.

space. Moving north along North 30<sup>th</sup> Street there is an existing three-family dwelling at 3000 R Street. To the east there is also an existing two-family dwelling at 3000.5 Q Street. Based on that context, the surrounding area is denser than the current zoning would suggest.

## **EXISTING ZONING**

The Property is zoned R-6 Single-Family Attached Residential, which does permit the proposed two-family detached dwelling use provided that a lot area of 6,000 square feet and a lot width of 50 feet are provided. The surrounding properties to the North, East, and South are also zoned R-6. Slightly farther to the south, the properties are zoned B-2 Community Business.

## **MASTER PLAN DESIGNATION**

The Master Plan recommends "Single-Family (medium density)" for the Property. The Master Plan describes this land use category as follows: "Primary uses are single-family and two-family dwellings, both detached and attached, at densities of 8 to 20 units per acre...Typical zoning classifications that may accommodate this land use category: R-5A, R-6 and R-7." There are also a variety of general housing goals contained in the Master Plan Neighborhoods and Housing chapter that are applicable to the request. These goals include, among other things, recognition of the need for the continued creation of market rate housing and a desire for neighborhoods to provide a variety of housing choices while remaining culturally and economically diverse.

# **Proposal**

## **PROJECT SUMMARY**

The proposed development includes the construction of a two-family detached dwelling on the Property with two accessory parking spaces.

## **PURPOSE OF REQUEST**

The Property consists of a single lot of record that is of typical size and configuration for the vicinity. The Property has a lot width of roughly 28.00' and contains approximately 3,517.92 square feet of lot area. The owner would like to construct a two-family dwelling on the Property. The R-6 district does permit two-family detached dwellings; however, the required lot width and lot area cannot be met. Therefore, a SUP is required in order to permit the proposed development.

The Property's lot width and area are compatible with other lots in the vicinity, which vary in size but are all characteristically smaller urban lots. On the subject block face, a majority of the lots are developed with single family homes that do not comply with the current R-6 requirements. These dwellings were typically built with minimal side-yard setbacks, and are substandard where the 50 feet of lot width and 5,000 square feet of lot area required for single-family detached dwellings are concerned. Based on this historic lot pattern, many of the lots in the vicinity are nonconforming with regard to lot area and lot width.

In exchange for the SUP, the intent of this request is to ensure a high-quality market rate infill development. The overall project would be appropriately dense and efficient. At the same time, it would remain respectful to the historic lot pattern in the vicinity thereby remaining consistent with

the predominant character of the area. Finally, the quality assurances conditioned through the SUP would guarantee a higher quality development than might otherwise be developed by right.

## PROJECT DETAILS

The two-family detached dwelling would be two stories in height and read as a single-family home from the street. The massing of the building is consistent with the scale and character of other nearby dwellings and is therefore respectful of the historic development pattern in the area. The architectural design is modern architecture that is "of the day", which works well in the context given the variety in the existing architectural styles in the area. The proposed, desirable, modern façade increases the diversity of design options in the block. The building would contain approximately 2,600 square feet of total floor area with both the ground floor unit and upper floor unit containing approximately 1,055 square feet of floor area. Each unit would have two bedrooms and 2 baths with spacious and modern floor plans containing open living areas.

The buildings would be clad in cementitious siding in order to ensure quality and consistency with many other dwellings in the vicinity. Full-width rear porches are proposed for both units that would provide usable outdoor area for future occupants. Two parking spaces are proposed for the two dwellings. Parking spaces would be located to the rear of the dwellings and accessed by the rear alley.

## Findings of Fact

The following are factors indicated in Section 17.11 of the Charter and Section 114-1050.1 of the Zoning Ordinance relative to the approval of special use permits by City Council. The proposed special use permit will not:

- *Be detrimental to the safety, health, morals and general welfare of the community involved.*

The proposed SUP for high-quality infill construction will not impact the safety, health, morals and general welfare of the nearby neighborhoods.

- *Tend to create congestion in streets, roads, alleys and other public ways and places in the area involved.*

The proposed SUP will not result in significant traffic impacts to nearby residential neighborhoods. The negligible traffic generation and two off street parking spaces for the two dwelling units will create no congestion on streets, roads, alleys or any other public right of way.

- *Create hazards from fire, panic or other dangers.*

The property will be developed in a manner consistent with the requirements of the building code and in accordance with the requirements of Fire and Emergency Services. The City's codes applicable to this development are designed to eliminate such hazards.

- *Tend to overcrowding of land and cause an undue concentration of population.*

The proposed SUP will not tend to over crowd the land or create an undue concentration of population.

- *Adversely affect or interfere with public or private schools, parks, playgrounds, water supplies, sewage disposal, transportation or other public requirements, conveniences and improvements.*

The proposed SUP would not adversely affect the above referenced City services.

- *Interfere with adequate light and air.*

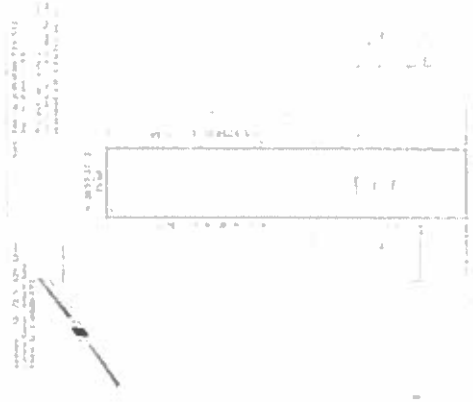
The light and air available to the subject and adjacent properties will not be affected. The proposed buildings are of compatible massing and spacing to the existing in the vicinity. As a result, this request will not interfere with the provision of adequate light and air to the adjacent buildings.

## Summary

In summary we are enthusiastically seeking approval for the construction of the proposed two-family detached dwelling. The building has been thoughtfully designed in order to provide appropriate, high quality market rate infill development. The request would contribute to the ongoing revitalization of the neighborhood, upgrading the Property while maintaining a desirable variation in housing style and density in the vicinity and providing for continued economic diversity in housing options within the neighborhood.

The proposed development would help complete a consistent urban fabric in a block face in which a number of lots remain vacant. An appropriate urban form coupled with the provision of accessory parking to the rear of the property would give the property the much-desired traditional neighborhood design which is appropriate to this area of the City. The provision of off-street parking spaces per zoning standards would help mitigate any impact on parking related to the development. Finally, the quality assurances conditioned through the SUP would guarantee a higher quality development than might otherwise be developed by right.

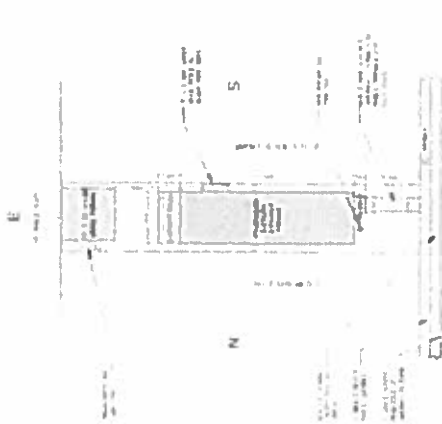

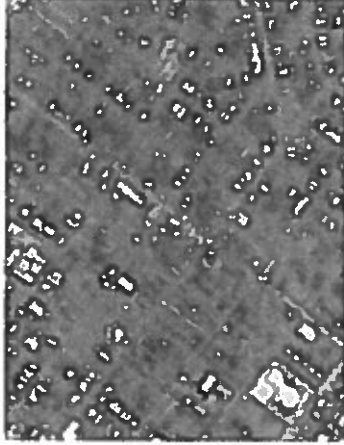

## SCOPE OF PROJECT

The project consists of the design and construction of a new 2-story duplex building located at 1110 1/2 N. 30th Street, Richmond, Virginia. The building will be constructed on a lot that is currently vacant. The project includes the design of the building footprint, the foundation, the structural frame, the exterior walls, the roof, the interior walls, the floors, the stairs, the elevators, the mechanical systems, the electrical systems, the plumbing systems, and the fire protection systems. The project also includes the design of the site plan, the parking lot, the driveway, the sidewalk, the landscaping, and the utility connections.
