## 4. Provide public comment, either during the Citizen Comment Period or regarding legislation considered by the Council, during the live virtual meeting via Microsoft Teams.

To request to speak during the Citizen Comment Period or during any of the meeting's public hearings, you must sign up prior to the meeting by either:

- 1. Calling the City Clerk's office at 646-7955 and selecting option 3. If staff is not available to take your call, please leave a voicemail with your request to speak, your name, and your contact number, and the City Clerk's staff will call you to sign you up; or
- 2. Sending an email to <u>CityClerksOffice@richmondgov.com</u> with your request to speak along with your name.

Public speakers must make contact with the City Clerk's office no later than **Monday**, **January 11**, **at 10:00 a.m.**, to participate during the meeting. Participation guidelines and instructions will be provided to individuals before the meeting.

Rule IV(G) of the City Council's Rules of Procedure applies to all Citizen Comment speakers except that the speaker must request to speak no later than 10:00 a.m. on the date of the meeting rather than 12:00 noon on the date of the meeting.

Those who have signed up to speak, either during the Citizen Comment Period or concerning a specific item of legislation before the Council, will be called upon at the appropriate time, and the applicable time limits will be enforced.
