- General Fund / Governmental Activities (transportation infrastructure, facilities including courts, fleet, floodwall and levees, canals), Enterprise Funds / Business-type Activities (parking, cemeteries, water, wastewater, stormwater, natural gas)
- From the CAFR for FY2020
 - Total Capital Assets for Governmental Activities were \$1.243 billion

The majority of the CIP in FY22 will be capital maintenance:

From the CAFR, capital asset depreciation has been provided over the estimated useful lives using the straight-line method as follows:

- Governmental:
 - Infrastructure 20 to 50 years
 - Buildings and structures 20 to 50 years
 - Fleet / Equipment and other assets 2 to 20 years
- Enterprise Funds:
 - Gas production, distribution, equipment 17 to 34 years
 - Water pumping, treatment, distribution, equipment 20 to 50 years
 - Sewage gathering and treatment equipment 20 to 50 years
 - Cemeteries 2 to 20 years
 - Buildings and structures 20 to 60 years
 - Equipment and other assets 2 to 20 years

Priority for CIP starting in FY22

- Heritage center campus: Over a five-year period the city will invest between \$25 million and \$50 million to commemorate the complete story of slavery in Shockoe Bottom.
 - A pavilion and museum at the Devil's Half Acre Site
 - Planning requirements for the proposed Heritage Center
 - Design of and improvements to the Richmond Slave Trail and Trail Head
 - The acquisition of 1305 North 5th Street and the extension of the Slave Trail to that property.
- Commonwealth of Virginia investment of \$9 million for the development of a Slavery Heritage Site and improvements to the Slave Trail in Richmond's Shockoe Bottom neighborhood. This funding will support efforts to preserve the area known as the Devil's Half-Acre, or Lumpkin's Jail, as a historical site.

Also starting in FY22

- In October Mayor Stoney announced George Wythe High School will be the next major school facility project to benefit Richmond's students. The Dreams4RPS Strategic Plan, supported by the School Board and funded in full by the Stoney administration, identified Wythe as the next facility in need of reinvention and rebuilding.
- Central Virginia Transportation Authority provides new funding opportunities for priority transportation investments. Transportation funding generated through the imposition of an additional regional 0.7 percent sales and use tax and a wholesale gas tax of 7.6 cents per gallon of gasoline and 7.7 cents per gallon of diesel fuel. This funding can be used for locally for paving, sidewalk and multimodal capital projects. Funding will also be used regionally for transportation and public transportation projects.

And finally in FY 22, 2019-09 Richmond Fire Department Fire Apparatus and Equipment Audit City Auditor's Office March 1, 2019

- The City does not have defined capital funding sources to address the aging fleet.
- Also, the replacement decision for purchasing a new fleet apparatus lies within the Department of Public Works (Fleet Services).
- The City is facing an aging RFD fleet, and in five years 46% of their apparatuses will be 25 years old. Depending on age, mileage, engine hours, preventive maintenance and other factors, some apparatuses may need replacement before 25 years.
- As each piece of equipment can cost 500K or more, this will require significant capital funding in five years, costing approximately \$10 million.
- Recommendation 4. We recommend that RFD work with Fleet Services to identify the aging fleet and to identify actions which need to occur in the Capital Improvement Program to replace apparatuses as they approach the retirement age.

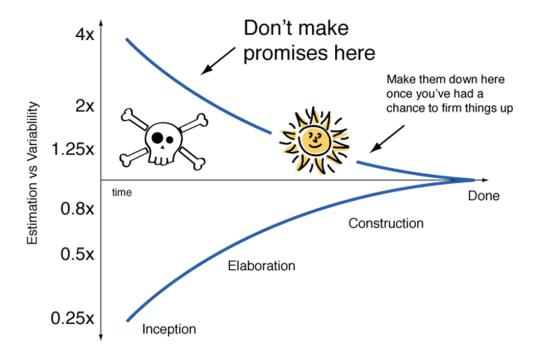


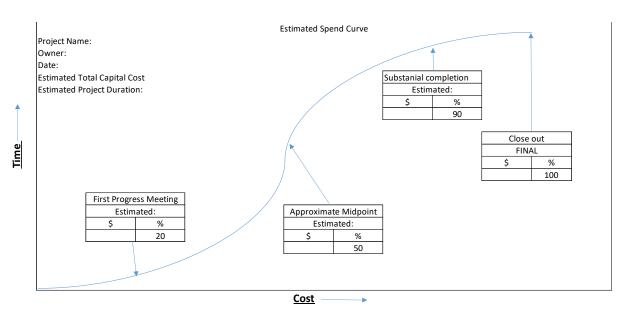

Capital project development by PMs

- Late August and early September PMs need to have certainty in the priorities of their clients, CAO and the mayor.
- Also, late August and early September, working with the city council chief of staff, the priorities of the city council members are transmitted in writing.
- PMs work to get information ready for hand-off to their clients and the budget department to begin the finance and administration portfolio work from September through early November.
- Adoption of the CIP budget in advance of the 5 and 20 year plan needs as much attention as the final authorizations for the upcoming year.

Continuous improvement of city PMs

- Project manager training and certification to formalize training and qualification of project managers in the city of Richmond.
 - Project Management Institute (PMI) instruction through Virginia State
 University and training on the Commonwealth of Virginia Construction and
 Professional Services Manual (aka, "the CPSM" or "the Manual")
 - Standards, policies, terms, conditions, and procedures to be followed in procuring professional design and construction services.
