

2021 Virginia General Assembly Regular Session

Week 3 Report: January 25-30, 2021

City of Richmond

The 2021 regular General Assembly session's third week of activity saw the Senate approve its resolution of censure for Senator Amanda Chase. The resolution was rewritten to remove the reference to her participation at the January rally at the U.S. Capitol and instead focused on numerous other instances involving her conduct.

Lost in all the attention that issue received was action on numerous issues of high priority for the Governor and Democratic majority. Although the General Assembly spent 84 days in a Special Session this past fall dealing with police and criminal justice reform and the pandemic impact, this session has continued to see even more legislation dealing with these issues.

The following are among the **criminal justice bills** being championed by the Governor and Democratic majority:

HB 1815 (Heretick), HB 2312 (Herring), SB 1243 (Morrissey), SB 1406 (Ebbin) would legalize marijuana for recreational use. The Herring and Ebbin bills, which run into the hundreds of pages, were drafted by the Governor's office and cover everything from growing marijuana to expungement of marijuana related criminal records. A JLARC study completed last year laid out a four year process that would occur prior to the first legal retail sale. HB 2312, which has been heavily amended, has cleared the General Laws Committee, and the Courts of Justice Committee. It is currently awaiting action in the House Appropriations Committee. SB 1406 is on a similar path having cleared the Rehabilitation and Social Services Committee. It now awaits action by the Senate Judiciary Committee and is then likely to go to the Finance and Appropriations Committee before heading to the floor. It too has been heavily amended. The House and Senate have taken different approaches to certain aspects of the issue which will likely need be resolved in a conference committee later this month.

Bills that would **abolish the death penalty** are also moving forward, albeit at very different speeds. <u>HB</u> <u>2263</u> (Mullin) is awaiting action by the House Courts of Justice Committee this week after being amended and recommended by a subcommittee. <u>HB 1779</u> (Carter) was incorporated into the Mullin bill. <u>SB 1165</u> (Surovell) has cleared committee action and sits on the floor of the Senate where action was delayed several times last week.

Two bills would **abolish minimum mandatory sentences**, another major priority of the Governor and Democratic majority. <u>HB 2331</u> (Mullin) was amended and reported from the House Courts of Justice Committee. It is now being reviewed for cost implications by the House Appropriations Committee.

<u>SB 1443</u> (Edwards) is in a similar position having been amended by the Senate Judiciary Committee and referred to the Senate Finance and Appropriations Committee. There are differences in the two bills as amended.

An effort to **increase the number of judges on the Virginia Court of Appeals and expand its jurisdiction** is moving slowly. <u>HB 2112</u> (Herring) would expand the court from 11 to 15 judges while <u>SB 1261</u> (Edwards) would expand the court to 17 judges. SB 1261 was amended and cleared the Senate Judiciary Committee on an 8-6-1 vote. It was then sent to the Finance and Appropriations Committee for a fiscal review while HB 2112 remains in the House Courts of Justice Committee with no action taken.

The issue of **qualified immunity for law enforcement officers** was hotly debated during the special session with the House and Senate having very different views about how to approach the issue. There was no resolution and two bills have been introduced that again attempt to address this issue that is of particular importance to the Virginia Legislative Black Caucus. <u>SB 1440</u> (Surovell) was referred to the Senate Judiciary Committee and is expected to be heard this week. <u>HB 2045</u> (Bourne) was recommended to be laid on the table after being heard by a House Courts of Justice subcommittee on Friday.

Other priority issues include the following:

Two bills intended to **expedite and facilitate the administration of Covid-19 vaccination programs** are on the fast track to passage on an emergency basis. <u>HB 2333</u> (Bagby) has passed the House and is awaiting final action on the Senate floor this week while <u>SB 1445</u> (Dunnavant) has passed the Senate and is now on the House floor with final action slated early this week.

Legislation to **mandate that employers provide paid sick leave to their employees** failed to advance in the 2020 session, despite being a House Democratic priority. While several bills dealing with this issue have been introduced, two bills backed by the Governor are HB 2016 (Ayala) was reported from the House Labor and Commerce Committee this week on an 11-9 vote and sent to the House Appropriations Committee for a fiscal review. HB 2103 (Reid) which takes a different approach to the issue, was amended and similarly approved. SB 1330 (Boysko), which is identical to HB 2016, was killed in the Senate Commerce and Labor Committee early in the session. SB 1219 (Favola) directs the State Corporation Commission's Bureau of Insurance to review and make recommendations, including any necessary statutory and regulatory changes, to authorize the SCC to approve the sale of individual and group paid family leave plans in Virginia. It has passed the Senate.

Attorney General Mark Herring is behind two bills that would implement the national opioid court settlement which expected to result in hundreds of millions flowing to the state. HB 2322 (Herring) was amended and cleared the House General Laws committee this week before being sent to the Appropriations Committee for review. SB 1469 (Barker) was approved as introduced by the Senate General Laws and Technology Committee this week and then sent to the Senate Finance and Appropriations Committee.

The week ahead

We are nearing the midpoint of the session. Committees and subcommittees will be pressing to clear their dockets since Friday is "crossover day" or the last day that each house may act on legislation originating within their body. Beginning Saturday, the chambers can only act on bills originating in the other body. The budget bill operates on a different schedule and budget markup will also occur this week. Subcommittees of House Appropriations Committee and Senate Finance and Appropriations Committee huddle with their staff to review and make decisions on amending the budget. Those decisions will be made public next Sunday as they are reported to the full committee. Each committee will then act on those recommendations. Meetings times for the two committees have not yet been set.
