ORDINANCE/RESOLUTION SUMMARY

An ordinance s requested to amend Section 30-114 and 30-116 of the City Code to change the location of Precinct 111.

BACKGROUND

The current polling location for precinct 111 is American Legion, located at 1708 Commonwealth Avenue, Richmond VA, 23230. American Legion has informed the Office of the General Registrar that they would not be able to host future elections in their facility due to changes in management.


The Church of the Holy Comforter, located at 4819 Monument Avenue, Richmond, VA 23230 has agreed to serve as the polling place for Precinct 111. The proposed location is ADA compliant, and within one mile of the current polling location as required by the Code of Virginia. Upon adoption of this ordinance, all registered voters (currently 1,827) affected by this change would be notified at least fifteen days before the election on June 8, 2021, pursuant to the requirements of §24.2-306 of the Code of Virginia.

The requested introduction date is April 26, 2021. Section 24.2-306 of the Code of Virginia prohibits changes to polling places within 15 days of a primary election. As such, this ordinance must be adopted prior to May 26, 2021. Notice of this proposed change must be published prior to enactment one a week for two successive weeks before adoption.
