Photo Speed Camera Program

The Commission supports the use of photo speed cameras to enforce speed limits in school zones and work zones within the City, particularly on the high injury street network; and supports the City of Richmond to implement a safe speeds demonstration project through a partnership with the DMV's Governor Highway Safety Office using photo speed enforcement cameras in school zones and work zones to be a model for the United States.

FY22 CVTA Budget

The Commission supports the City of Richmond in distributing such funds to projects through a balanced approach to further an equitable multi-modal transportation network.

FY22 Transportation Budget

Commission supports the establishment of the Complete Streets budgetary item and supports the City of Richmond in utilizing Complete Streets funds through a balanced approach that ensures the safety of people of all ages and abilities walking, biking, accessing transit, and driving. The Commission recommends the City of Richmond employ funds utilizing a transportation equity lens to improve the transportation network across the city as a whole.
