Hello, I'm Sara Sass, an attorney who lives in Virginia. Richmond is a beautiful city full of history for all Americans to enjoy and learn from. I would like to submit the following comments in advance of the city meeting on June 10th, which I will also be attending.

The city of Richmond's plan to disturb General A.P. Hill's gravesite in Richmond is very disturbing: <u>https://nationalfile.com/virginia-democrats-plan-to-dig-up-grave-of-confederate-general-a-p-hill-no-plan-to-move-coffin/</u>

I do not know if the city of Richmond is aware that by pursuing these plans, the city will be committing class 4 and 6 felonies. According to the Code of Virginia 18.2 - 126, if a person (the city of Richmond would obviously send a crew to handle the grave disturbance) unlawfully disturbs or disinters a human body which has been placed in a vault or grave, he or she is guilty of a class 4 felony. This act can carry fines over one hundred thousand dollars, but courts often order higher amounts if there is evidence of malice or wanton disregard. This is especially the case since Hill was buried standing, so disturbance of the body will obviously occur. I have seen no permits or any kind of expert opinion the city has retained to show how corpse disturbance will not occur. Also according to the Code of Virginia 18.2 - 126, if a person willfully and intentionally defiles a dead human body (Mayor Stoney indicated his hatred of all Confederates in statements made in July 2020 so this would be easily proved) he or she is automatically guilty of a class 6 felony. There is no statute the city of Richmond could hurriedly enact to avoid this. Given the city's propensity to store confederate statues in the sewage plant, I don't know how the city won't be defiling this corpse.

Currently, Mayor Stoney has opioid and unemployment crises in Richmond, on top of COVID. Yet his website, full of accolades about himself, makes no mention of his policy to address these problems. Mayor Stoney is happy to spend tens of thousands of dollars on unpopular stances (the ten people tops who repeatedly appear at these statue removals is telling) and \$0 on what would help the people of Richmond. Instead of tweaking his bio page a little more and giving \$250k to "non-citizen" housing, maybe Mayor Stoney should take a moment to appreciate his taxpayers.

Good morning, Alex,

I would like to be clear that I completely support the removal of Confederate monuments in Richmond. However, looking at the pedestal removal plan for 0 N 29th St by Libby Hill Park, it appears the entire area will be repaved to flat roadway. I have concerns about traffic safety if this is the path chosen. With the historic overlook at that location, there is a high level of vehicle (cars, buses, segways, tuk tuks, etc) and pedestrian traffic heading in various directions. Folks are making left turns onto Libby Terrace, making u-turns to head north on 29th, parking in the circle, or just driving by slowly to take in the historic view. Without a structure or adequate signage to direct traffic, I anticipate confusion and potential accidents.

I hope the removal plan can be modified to address these concerns. I notice some of the other monuments will keep their greenspace and incorporate plants. I know the Confederate Soldiers and Sailors Monument doesn't currently have any greenspace, but maybe this is an opportunity to make that sort of addition.
