# Dr. Thelma Bland Watson

Executive Director, Senior Connections, the Capital Area Agency on Aging

Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, does hereby recognize, honor, and celebrate the life of the late Dr. Thelma Bland Watson for her dedicated service to championing the needs of seniors.

Providing assistance for her grandmother at age 9 started Dr. Thelma Bland Watson down a lifelong path focused on improving the care of seniors at the federal, state, and local levels. Her career began shortly after graduating from Virginia State University with a degree in sociology. She later earned a Master's degree in gerontology as well as a Doctorate in public policy and administration from Virginia Commonwealth University.

Dr. Watson served from 2002 until her passing as the Executive Director of Senior Connections, a 501C nonprofit organization based in Richmond that provides opportunities to improve the quality of life of seniors and their caregivers. During Dr. Watson's tenure, Senior Connections grew to serve 25,000 seniors per year via a spectrum of programs including home-delivered meals, health and wellness classes, money management, and counseling, among many others. To spotlight the financial needs of Senior Connections, Dr. Watson started the "Empty Plate Luncheon", an annual fundraiser that used empty plates to symbolize unmet demand for services.

Before her tenure at Senior Connections, Dr. Thelma Bland Watson served the senior population in a variety of policymaking roles at all levels of government, including the National Committee on Social Security and Aging; the Virginia Department for Aging and Rehabilitative Services (where she was appointed and reappointed by both Democratic and Republican Virginia Governors); and the Crater District Area Agency on Aging and Crater Planning District in the Petersburg area. She also served on a variety of advisory boards and commissions related to aging, medical care, and quality of life improvement.

In recognition of her contributions and efforts to improve the lives of others, Dr. Watson received many honors and accolades over her career, including recognition in 2015 with a Humanitarian Award from the Virginia Center for Inclusive Communities, and being named a 2019 Person of the Year Honoree by the Richmond Times-Dispatch.

### Horace Alphonso Carter III Helped Richmonders Swim Safely for More Than Half a Century

Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, does hereby recognize, honor, and celebrate the life of the late Horace Alphonso "Bubba" Carter III for more than 50 years of service to the Richmond community.

Growing up in the Navy Hill and Jackson Ward neighborhoods of Richmond, Mr. Carter attended Richmond Public Schools and graduated from Maggie L. Walker High School in 1958. Afterwards, he attended Virginia Commonwealth University, graduating with a Bachelor of Science degree in Recreational Therapy.

Mr. Carter's lifelong love of swimming led to a career with the Richmond Department of Parks, Recreation, and Community Facilities, where he was employed as a lifeguard at the swimming pool at Brook Field Park which, at that time, was the only city swimming pool open to Richmond's African American community. Mr. Carter later served as a lifeguard at the now-closed Calhoun Community Center swimming pool at Gilpin Court and the Swansboro Pool, as well as a seasonal lifeguard post-retirement.

A tireless advocate for swimming safety, Mr. Carter taught swimming lessons to Richmond's youth in a nurturing, safe environment. He undoubtedly inspired, motivated, and empowered countless young minds, hearts, bodies, and spirits as they learned how to safely navigate the water. In addition to personally serving as a swimming instructor, Mr. Carter also advocated for swimming instruction while serving in management positions over the years at multiple Richmond Department of Parks, Recreation, and Community Facilities sites, including the Blackwell Pool and the swimming pools at the Battery Park and Calhoun Community Centers.

In addition to his tenure with the Richmond Department of Parks, Recreation, and Community Facilities, Mr. Carter served as a recreational therapist at the Hunter Holmes McGuire Veterans Affairs Medical Center for 20 years.

By virtue of the authority vested in the United States of America, Commonwealth of Virginia, Virginia Code of Laws, and the Richmond City Charter: Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, does hereby and officially recognize the:

### Richmond and Virginia Anniversary of Hiring the First Career Firefighters of African American Descent

Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, has established July 1 as the Richmond and Virginia Anniversary of Hiring the First Career Firefighters of African American Descent.

Blazing the way for racial integration of Richmond and all career fire departments in Virginia, on July 1, 1950, the Richmond Department of Fire and Emergency Services (then named the Richmond Fire Bureau) hired and trained 10 career Firefighters of African American descent, assigning them to Fire Engine Company # 9, then located at Fifth and Duval Streets in the city's Northside.

The distinguished roster of Richmond's and Virginia's first Firefighters of African American descent includes Charles L. Belle, William E. Brown, Douglas P. Evans, Harvey S. Hicks II, Warren W. Kersey, Farrar Lucas, Bernard C. Lewis, Arthur L. Page, Arthur C. St. John and Linwood M. Woodridge. Arthur C. St. John was recalled to military service in 1950 and Farrar Lucas resigned in 1951; their vacancies were filled by Frederick J. Robinson and Oscar L. Blake, respectively.

The pioneering efforts of these outstanding individuals are a tributes to their dedication, strength, and personal achievement, and mark the continued progress of Virginia, Richmond, and the Richmond Department of Fire and Emergency Services in leading the way for progress during a disgraceful time in our Nation's history when the practice of racial segregation denied many people of equal education, work opportunity, facilities, and accommodations.

Due to its historic significance, in 2010, Richmond City Council officially commemorated July 1 for the Richmond and Virginia Anniversary of Hiring the First Career Firefighters of African American Descent and Richmond forever venerates these intrepid souls and the significance of their achievement on behalf of our city, state, and nation.

In 2019, Richmond City Council further established the recognition of July 1 as the Richmond and Virginia Anniversary of Hiring the First Career Firefighters of African American Descent and set that date in permanence and perpetuity for that purpose.

Essential to the safety and security of Richmond residents and visitors is having dedicated career fire and emergency services, which includes firefighters, officers, staff, and support personnel, as provided by the Richmond Department of Fire and Emergency Services, who serve with honor and fortitude in delivery of their duty, which, due to the exceptional nature of their work, puts them in harm's way.

**Now, Therefore,** Richmond City Council again re-affirms the day of July 1 as the Richmond and Virginia Anniversary of Hiring the First Career Firefighters of African American Descent; acknowledges these trailblazing firefighters; and, heralds this important chapter in the advancement of our city's progressive narrative arc on behalf of all its residents.
