Council President Cynthia Newbille called the meeting to order at 6:21 p.m., and presided.

ELECTRONIC MEETING ANNOUNCEMENT

City Clerk Candice Reid, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, as most recently amended by Ordinance No. 2020-232, adopted December 14, 2020, announced the meeting would be held through electronic communication means. City Clerk Reid stated notice of the meeting was provided to the public through a public information advisory issued on June 17, 2021, and through Legistar on the city website in accordance with usual practice. She also stated members of the public were encouraged to provide comments in writing prior to the meeting and all comments received prior to 10:00 a.m., on Monday, June 28, 2021, were provided to Council members. Ms. Reid indicated that members of the public who signed up to speak and provide comment would be called to speak at the appropriate time.

Invocation was offered by Reverend Tyel Banks of Pure Apostolic True Holiness Ministry, P. O. Box 36528, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

Councilwoman Reva Trammell joined the meeting at 6:25 p.m.

CITIZEN SPEAKER GUIDELINES

Upon the President's request, Deputy City Clerk RJ Warren provided citizen speaker guidelines.

AWARDS AND PRESENTATIONS

There were no awards or presentations.

APPOINTMENTS AND REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

CITIZEN COMMENT

Citizens were provided an opportunity to offer comments in writing prior to the Formal City Council meeting. Vernon D. Howard, Sr. addressed Council and informed members of an issue with homeless individuals gathering in front of his home on West Marshall Street. Mr. Howard stated that he had previously addressed the issue with the Richmond Police Department, former Councilmember Kim Gray, and Councilor Katherine Jordan. Mr. Howard also stated it was difficult to enjoy his front porch, due to the noise and behavior occurring from the individuals. Mr. Howard requested Council help address the issue.

Councilor Katherine Jordan stated that she had previously discussed the issue with Mr. Howard and additional work would be necessary to address issues of homelessness across the city.

President Cynthia Newbille summarized the bid offer for ORD. 2021-163 from Urbana at Hioaks, LP.

Rosemary Green, Department of Public Utilities deputy director, provided additional information regarding ORD. 2021-163, and stated that city administration supported the acceptance of the bid put forward by Urbana at Hioaks, LP.

Councilor Stephanie Lynch moved to accept Urbana at Hioaks, LP's bid and to adopt ORD. 2021-163, which was seconded.

Public Hearing

Jennifer Mullen, Roth Jackson member, on behalf of Urbana at Hioaks, LP, provided information regarding how the easements referenced in ORD. 2021-163, would benefit Urbana at Hioaks, LP, and provide pedestrian access for citizens.

There were no further comments or discussions and the motion to accept Urbana at Hioaks, LP's bid and to adopt ORD. 2021-163, was unanimously approved.

The following ordinance was considered:

ORD. 2021-164

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute a Memorandum of Understanding Between the City of Richmond and the Richmond Redevelopment & Housing Authority Regarding a Joint Application for a Choice Neighborhoods Planning Grant for the purpose of seeking funding for the development of a comprehensive neighborhood revitalization strategy that includes the Gilpin Court public housing complex located at 102 West Charity Street.

Sharon Ebert, Deputy Chief Administrative Office for Planning, Community and Economic Development, provided an introduction and additional background information regarding the proposed ordinance.

Councilor Ann-Frances Lambert also provided an introduction of ORD. 2021-164, and stated that she did not want the displacement of residents to occur during the redevelopment of Gilpin Court. Councilor Lambert also stated that she wanted to ensure the redevelopment was community driven, and she informed members she would vote to adopt the proposed ordinance.

Vice President Ellen Robertson stated that she was concerned because she was unware of the Richmond Redevelopment and Housing Authority's (RRHA) position on ORD. 2021-164, and if the RRHA was ready to move forward on any redevelopment.

Ms. Ebert stated that any redevelopment was only in the pre-planning stage, and the acceptance of the funding grant referenced in ORD. 2021-164, would help accelerate the pre-planning phase of redevelopment.

Councilwoman Reva Trammell stated that she shared Vice President Robertson's concerns, and she also addressed the history of public housing redevelopments in the city.

Councilor Katherine Jordan stated that she was encouraged that the Department of Planning and Development Review was engaging with the residents of Gilpin Court regarding potential redevelopment. Councilor Jordan inquired if ORD. 2021-164 would provide funding for additional community outreach regarding redevelopment.

Ms. Ebert stated that the funding grant referenced in ORD. 2021-164, provides funding to employ staff and to compensate Gilpin Court residents for community outreach.

Councilor Stephanie Lynch inquired about funding for pool maintenance at Gilpin Court.

Acting Chief Administrative Officer Lincoln Saunders stated the challenge for the city providing funding for aquatic capital improvements was that the property is owned by RRHA, which prohibits the city from allocating capital improvement funding for the improvements.

Councilor Ann-Frances Lambert stated that she inquired about the pool improvements and maintenance from the RRHA Board of Commissioners, and she was informed that RRHA has a balance of \$1,500,000 in discretionary funding for pool improvements.

Vice President Ellen Robertson stated her concerns with progress and proposed completion schedules of other housing redevelopments in the city. Vice President Robertson also requested that community residents be engaged in the redevelopment process.

Ms. Ebert informed Council that city administration would continue to work with the RRHA to complete current redevelopment projects. Ms. Ebert stated that the RRHA Board of Supervisors had approved the memorandum of understanding referenced in ORD. 2021-164. Ms. Ebert also stated that the redevelopment of Gilpin Court was still in the pre-planning phase, and no opportunities for housing vouchers are available at this time.

There were no further comments or discussions and **ORD. 2021-164 was unanimously adopted.**

Councilor Katherine Jordan provided an introduction and additional background information regarding the proposed ordinances. Councilor Jordan shared her appreciation for the research and efforts conducted by Sesha Moon and Enjoli Moon regarding the ordinances.

Public Hearing

Dr. Sesha Moon, Jackson Project co-creator, stated her appreciation for the ability to address Council regarding the proposed ordinances.

Enjoli Moon, Jackson Project co-creator, shared her appreciation for Council providing an opportunity to address the street designations referenced in the proposed ordinances. Ms. Moon stated that the Jackson Project is dedicated to promote aspects of Jackson Ward's origin story. Ms. Moon further stated that the Jackson Project's research identified that several streets within Jackson Ward were named after Confederate affiliated individuals, and that the proposed street designations would help counter that Confederate narrative, while providing recognition to Jackson Ward's legacy and heroes.

President Cynthia Newbille shared her appreciation for the work Sesha Moon and Enjoli Moon provided in celebration of Jackson Ward's 150th anniversary.

Councilor Katherine Jordan stated that the street recognitions referenced in the proposed ordinances exemplified the type of action the city was promoting through the adoption of the Richmond 300 Master Plan: A Guide for Growth.

Vice President Ellen Robertson shared her appreciation for the work Sesha Moon and Enjoli Moon did in bringing recognition to the history of Jackson Ward.

Councilor Ann-Frances Lambert stated she would vote to adopt the proposed ordinances, and she shared her appreciation for the work done by Sesha Moon and Enjoli Moon.

Councilor Michael Jones shared his appreciation for the work of Sesha Moon and Enjoli Moon in recognizing the cultural history of Jackson Ward.

There were no further comments or discussions and ORD. 2021-165, ORD. 2021-166, ORD. 2021-167, ORD. 2021-168, ORD. 2021-169, ORD. 2021-170, ORD. 2021-171, ORD. 2021-172,
