ORDINANCE/RESOLUTION SUMMARY

This Resolution is to request installation of speed bumps as traffic calming measures on Seminary Avenue between N. Lombardy Street and Brookland Park Blvd.

BACKGROUND

This Resolution is to request installation of speed bumps as traffic calming measures on Seminary Avenue between N. Lombardy Street and Brookland Park Blvd. The speed bumps should be similar to the ones that are in place on Seminary, north of Brookland Park Blvd. The goal of and key issues for this Resolution are traffic calming measures for resident safety, including the safety of children and safety due to bike lanes.

The patron is requesting installation of speed bumps as the traffic calming measure to address the concerns expressed and experienced by the residents. Members of the community have shown their support for the installation of the speed bumps having passed a Resolution and the collection of petitions advising of their support. The Edgehill-Chamberlayne Civic Association passed a resolution in support of these measures. The Civic Association also collected petitions that included 63 signatures from residents.

In an email dated, February 21, 2021 (attached), the Department of Public Works suggests other traffic calming measures to respond to the traffic issues raised, which would install stop signs that would require "through traffic to stop four times". The patron is interested in the next steps of pursuing installation of speed bumps for safety measures for the issues raised.
