THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That section 4-243 of the Code of the City of Richmond (2020) be and hereby is **amended** as follows:

Sec. 4-243. Dogs running at large prohibited; penalty.

(a) [#] Except as otherwise provided in this section, it shall be unlawful for any dog to run at large. For purposes of this section, a dog shall be deemed to run at large while roaming, running, or self-hunting off the property of its owner or custodian and not under its owner's or custodian's immediate control. The term "immediate control," for purposes of this section, means physical restraint or confinement of the dog by a fence, tether, lead or leash. An electronic collar

or other similar electronic device does not qualify as a leash, lead, or other means of physical restraint.

(b) The leash, lead, or other means of physical restraint may be removed from a dog in

a designated and posted dog exercise area.

(c) The leash, lead, or other means of physical restraint may be removed from a dog on

private property other than the property of the owner, provided that the owner or person in control

of such private property has permitted such dog to be present without a leash, lead, or other means

of physical restraint.

(d) Any person who permits such person's dog to run at large shall be deemed in

violation of this section, and upon conviction thereof, shall be guilty of a Class 4 misdemeanor.

§ 2. This ordinance shall be in force and effect upon adoption.

PURPOSE: To authorize the Chief Administrative Officer to amend Sec. 4-243 of the Richmond City Code, Dogs running at large prohibited; penalty.

REASON: The requested amendment, attached, would modify the existing text to further define and clarify the conditions related to dogs running at large.

RECOMMENDATION: Approval.

BACKGROUND: In its current form, this section of Richmond City Code lacks clarity pertaining to the means of maintaining immediate control of an animal by physical restraint. The requested amendment seeks to update the section to include additional means deemed effective (such as a lead), while excluding other means deemed ineffective (such as an electronic collar), for these purposes. Additionally, this amendment seeks to allow a dog to run at large on private property, other than the property of the animal owner, provided the property owner has permitted such activity to occur. These changes will be keeping the practices and procedures of Richmond Animal Care and Control in alignment with industry best practices while prioritizing the safety and welfare of City animals and residents.
