**PURPOSE:** The purpose of this request is to amend Ordinance 2021-105 which assigned the funds received from the American Rescue Plan Act of 2021 to a special reserve.

**REASON:** The guidance from the Treasury Department has designated the funds as other financial assistance and not as a grant. As a result, the accounting treatment requires the funds be recorded in the General Fund as a deferred revenue until such time as the eligibility requirements have been met and revenues are earned. In order to ensure appropriate controls over the funds, the receipt of cash has been recorded in the general ledger. The Projects and Grants module will be used to manage the oversight for spending and will be the basis for reporting. The budget line items for spending and control will be derived from the forthcoming budget upon approval by City Council.
