Dear members of Richmond City Council:

I write to ask you to support spending ARPA funds in the following ways:

I ask you to spend to improve the city's vital green spaces, including our city's treasure, the James River and its park system.

I ask you to fully fund support for families to care for their children, including child care, stable and safe housing, parks, community centers, and safe access to recreation and nature.

I hope we will spend money to beautify those areas of the city we have too long ignored, so all residents may take pride in their neighborhoods, wherever they may live; and so these neighborhoods can be a respite from stress, with sufficient tree and greenspace coverage to reduce heat islands and mitigate storm runoff.

Clearly, spending ARPA funds on greener infrastructure, weatherization of homes, lead line abatement, and stormwater capacity (and maintenance!) is important. We must protect people's lives and property, as well as shield the James River from pollutants, as climate change impacts effect our city and natural resources.

I hope to see us increase the capacity and liveability of our low-income housing stock, and hope it is developed in ways that are informed and lead by those who will live there, and to maximize opportunities for families to gain access to amenities that many in Richmond take for granted, such as schools, transportation, healthy affordable food, libraries, doctors' offices, and parks. I also hope that we consider issues such as the social determinants of health, to also include tree coverage and greenspace to reduce heat islands.

Finally, I ask that you support public safety initiatives, especially those that affect our most vulnerable citizens: gun violence, and traffic safety. Richmond, VA should follow the lead of Richmond, CA, which has successfully reduced gun violence through innovative initiatives. We don't need to reinvent the wheel, and can learn from their example what works to reduce interpersonal violence.

We should also spend meaningfully to fix Richmond's terrible road designs that lead to injuries and deaths by traffic. As someone who tries to walk and bike the city as much as I can, I am intimately familiar with how dangerous our streets and intersections are. Even a person in a car cannot navigate many intersections safely, due to the many blind intersections where vehicles stopped at a stop sign from a side street must venture into a roadway they cannot see due to cars parked up to the intersection--into traffic that is invariably speeding (with drivers often on their phones). (We also do not enforce speed limits and thus people

drive way too fast.) These dangers especially impact those who do not have cars or cannot drive and have no choice but to navigate these dangerous roadways on foot or bike. We should turn high-pedestrian intersections (such as those at Belvidere with Franklin, Main, and Cary) into "scramble" or diagonal intersections, where all cars must fully stop as pedestrians cross. Recently, a person was killed at an intersection just a few blocks from my home. A stop light there--where cars typically speed way faster than the speed limit-- could have saved a life. We must commit to fixing our dangerous streets, to slowing traffic, and to making other forms of travel more convenient and safe enough that those who can will choose these. (And for bus travel: I've been shocked at how little we provide in terms of a place to sit out of the weather. In other cities, bus stops have at least a small shelter. Here, many stops do not even offer a bench or an overhang.)

If we use our ARPA funds to fix some of this infrastructure, we should use our general funds to increase the frequency of our street cleaning. In other cities, street cleaning takes place once or twice a week. Here we are lucky if streets are cleaned once or twice a year. (And since we almost never clean streets, we don't have good signage to alert people--and then we tow their cars, enriching the tow companies but burdening those already struggling to meet necessities). In the meantime, debris builds up, blocking sewer drains (try navigating the lakes that build around storm drains in some neighborhoods--even worse when frozen in winter!) and making the bike lanes (where debris invariably comes to rest) hazardous.
