Call to Order

Chair Andreas Addison called the meeting to order at 12:02 p.m., and presided.

Electronic Participation

Assistant City Clerk Pamela Nichols, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, as most recently amended by Ordinance No. 2020-232, adopted December 14, 2020, announced the meeting would be held through electronic communication means. Senior Assistant City Clerk Nichols stated notice of the meeting was provided to the public through a public information advisory issued on January 12, 2021, and through Legistar on the city website in accordance with usual practice. She also stated members of the public were encouraged to provide comments in writing prior to the meeting and all comments received prior to 10:00 a.m., on Tuesday, January 19, 2021, were provided to committee members. Mrs. Nichols indicated that members of the public who signed up to speak and provide comment would be called to speak at the appropriate time.

Public Comment Period

There were no public comment speakers.

Approval of Minutes

There were no corrections or amendments to the meeting minutes of Tuesday, November 17 2020, and the committee approved the minutes as presented.

Board Vacancies

Senior Assistant City Clerk Pamela Nichols reviewed board applications for consideration by the committee.

Vice Chair Ellen Robertson expressed concern regarding the number of vacancies for the Board of Building Code Appeals, Plumbing and Mechanical Division, and the impact the vacancies have on the board's ability to function.

Chair Andreas Addison requested a discussion regarding board appointments and vacancies at a future Organizational Development Standing Committee meeting.

Vice Chair Robertson asked about district representation for members currently serving on the Board of Fire Appeals.

Member Michael Jones joined the meeting at 12:13 p.m.

Vice Chair Robertson expressed support of having greater diversity among members appointed to the City Planning Commission and the screening of potential members to determine who may have conflicts of interest with items under consideration by the commission.

Member Michael Jones echoed a need for diverse representation on boards and commissions to reflect communities throughout the city. Mr. Jones stated he would like more robust discussions on possible revisions to the boards and commissions application process.

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute appropriate documents releasing the Richmond Redevelopment and Housing Authority and its successors in interest from the reversionary right of the City contained in a certain special warranty deed concerning the property known as 30 West Jackson Street for the purpose of allowing the Richmond Redevelopment and Housing Authority to sell the property for the development of a rental housing project for low-income residents.

Michelle Peters, Department of Housing and Community Development deputy director, introduced ORD. 2020-257.

Michelle Peters, Department of Housing and Community Development deputy director, introduced RES. 2021-R010.

Mario Wells with Enterprise Community Development explained that the proposed multifamily development would serve low-income individuals and families, and seven units will be income restricted to families earning 30% of the area median income (AMI).

There were no further comments or discussions and Vice Chair Ellen Robertson moved to forward RES. 2021-R010 to Council with the recommendation to approve, which was seconded and unanimously approved.

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute a Deed of Access Easement between the City of Richmond and AT Artisan LLC and American Tobacco Holdings LLC, for the purpose of granting an access easement to a portion of City-owned real property located at 400 Jefferson Davis Highway to AT Artisan LLC and American Tobacco Holdings LLC. **Patron:** Mayor Stoney

Alfred Scott, Department of Public Utilities senior deputy department director, introduced ORD. 2020-258.

ORD. 2020-259

To declare a public necessity for and to authorize the acquisition from Westmoreland Place Association of an easement of right-of-way over, upon, across, and through the streets located in the Westmoreland Place subdivision and known as Westmoreland Place, Virginia Avenue, Bolling Avenue, Powhatan Avenue, Rolfe Road, a portion of Pocahontas Avenue, and a portion of Charmian Road for public right-ofway purposes, and to authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute an Agreement between the City and Westmoreland Place Association in connection therewith.

There were no further comments or discussions and **Member Michael Jones moved to forward** ORD. 2020-260 to Council with the recommendation to approve, which was seconded and unanimously approved.

The following ordinance was considered:

ORD. 2021-002

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute an Urban Project Construction Agreement between the City of Richmond and the Virginia Department of Transportation to provide funding for the design and construction of multimodal improvements along U.S. Route 1 from its intersection with Brinser Street to its intersection with Chesterman Avenue, including access improvements at U.S. Route 1 and its intersection with North Hopkins Road and at U.S. Route 1 and its intersection with Harwood Street.

Patron: Mayor Stoney

Lamont Benjamin, Department of Public Works capital improvement projects (CIP) administrator, introduced ORD. 2021-002.

Bobby Vincent, Department of Public Works director, explained the project is funded through state funds and that improvements outside of the scope of the project will be a part of the city's CIP.

Vice Chair Ellen Robertson requested that the Department of Public Works meet with her and Councilwoman Reva Trammell to discuss proposed improvements.

Member Michael Jones emphasized the need for a more aggressive approach to address transportation safety throughout the city.

There were no further comments or discussions and Vice Chair Ellen Robertson moved to forward ORD. 2021-002 to Council with the recommendation to approve, which was seconded and unanimously approved.
