Councilor Andreas Addison arrived at 4:09 p.m. and was seated.

Councilor Katherine Jordan inquired regarding the preservation of green space in the 2nd District as a result of the proposed sale of the property referenced in Ord. 2021-267.

Sheila White, Finance director, presented a revenue impact analysis of Ord. 2021-189, which addressed city administration's concerns regarding the proposed adoption of the alternative business, professional and occupational license (BPOL) taxation legislation. A copy of the presentation provided has been filed.

Councilor Michael Jones arrived at 4:18 p.m. and was seated.

Councilor Andreas Addison presented his BPOL reduction strategy. A copy of the information provided has been filed.

Leonard Sledge, Economic Development director, addressed Council regarding Ord. 2021-189 and advised of a strategy to raise the BPOL tax floor as an alternative to the proposed legislation.

Acting Chief Administrative Officer Lincoln Saunders requested an opportunity to discuss other ways to provide relief to city businesses and suggested a meeting with the city's financial advisor, Davenport and Company, prior to the November 8, 2021 Formal Session of Council.

Councilor Michael Jones acknowledged his skepticism regarding the intended outcome of Ord. 2021-189 and questioned the factors which drive an owner's decision involving business location.

Councilor Katherine Jordan stated that she would like to hear from the business community in order to make an informed decision regarding Ord. 2021-189.

Vice President Ellen Robertson suggested the proposed legislation be continued to allow for further dialogue.

Councilor Addison commented on challenges to obtain information related to active business licenses and newly applied building permits, which he cited would better assist Council with making informed budgetary decisions regarding BPOL taxation.

There were no further comments or discussions concerning Consent and Regular Agenda items reviewed.

Redistricting Briefing

J. Gerald (Gerry) Hebert, Campaign Legal Center (CLC) senior consultant, presented Council with recommendations pertaining to the 2021 decennial redistricting of Council and School Board election districts. Mr. Herbert advised that with the current uncertainty of state legislative mapping and anticipated voting precinct changes, Council is under no pressure to redraw district lines since the next election is not until 2024. A copy of the information provided has been filed.

President Cynthia Newbille suggested scheduling a future work session to dicuss the presented recommendations after allowing Council an opportunity to review options.

Closed Session

At 5:03 p.m., Councilor Stephanie Lynch moved that the City Council hold a closed meeting pursuant to subdivision (A)(29) of section 2.2-3711 of the Virginia Freedom of Information Act to discuss terms and scope of a public contract involving the expenditure of public funds for an efficiency and fiscal review to be solicited where discussion in an open session would adversely affect the bargaining position or negotiating strategy of the City.

The motion was seconded and unanimously approved.

Councilwoman Reva Trammell departed at 5:45 p.m.

Councilor Michael Jones motioned to exit closed session. The motion was seconded and approved: Ayes 6, Addison, Jordan, Lynch, Jones, Robertson, Newbille. Noes None. Lambert and Larson were excused.
