To authorize the Chief Administrative Officer, for and on behalf of the 2023-249 City of Richmond, to accept funds in the total amount of \$1,488,000.00 from the Virginia Department of Transportation, to amend Ord. No. 2023-073, adopted May 8, 2023, which accepted a program of proposed Capital Improvement Projects for Fiscal Year 2023-2024 and the four fiscal years thereafter, adopted a Capital Budget for Fiscal Year 2023-2024, and determined a means of financing the same, by (i) establishing a new project for the Department of Public Works in the Transportation category called the "Automated Traffic Signal Performance Measures" project and (ii) increasing estimated revenues from the funds received from the Virginia Department of Transportation and the amount appropriated to the new Department of Public Works' Automated Traffic Signal Performance Measures project in the Transportation category by \$1,488,000.00, all for the purpose of funding the implementation of an Automated Traffic Signal Performance Measures project to provide traffic data collection devices at certain signalized intersections.

Director Vonck provided an overview of this paper.

Following the presentation, members of the Planning Commission asked clarifying questions regarding the details of the proposed ordinance, including details on previously approved Special Use Permits for ADUs, details on the results of those surveyed during the public outreach process, and the specifications of what types of requests for relief from the ordinance provisions might be heard by the Board of Zoning Appeals.

Mr. Poole opened the pubic hearing.

Monica Esparza spoke in opposition to this request, citing concerns with parking and absentee landlords.

Joh Gehlbach spoke in favor of the ordinance, on behalf of the Richmond Association of Realtors.

Seeing no one else wishing to speak, Mr. Poole closed the public hearing.

Following brief discussion, a motion was made by Commissioner Young, seconded by Commissioner Knight, that this ordinance be recommended for approval. The motion carried unanimously.

**11.** ORD.To authorize the special use of the property known as 2200 Ingram Avenue2023-243for the purpose of a residential development, upon certain terms and<br/>conditions. (8th District)

Shaianna Trump, Associate Planner, gave an overview of this request.

The applicant, Brian Jackson (Oakgrove Partners), provided the Planning Commission with additional information on the proposed development, including an overview of the public outreach that has been conducted, as well as the proposed site improvements and amenities.

Members of the Planning Commission asked Mr. Jackson to provide additional information affordability and tenant selection.

Mr. Poole opened the public hearing.

Charles Snelling spoke in favor of the proposal, on behalf of the Oakgrove Neighborhood Association.

Bishop Earnest Moore spoke in support of the proposal.

Robert Winfree spoke in support of the proposal.

Charles Willis, President of the Richmond Highway Neighborhood Clvic Association, spoke in favor of the proposal, citing potential benefits to the community.

Dale Alexander spoke in favor of the proposal.

Barbara Goode, President of the Oakgrove Civic Association, spoke in opposition to the request, requesting more time so that the neighbors can get additional details on the proposal.

Frank Wilson spoke in opposition to the request, noting that the community has not had enough time to provide feedback and expressing concerns with traffic.

Joe Brancoli spoke in opposition to the request as representative to the Falls of the James River Sierra Club. Mr. Brancoli stated that he supports the neighbors' requests for additional time to consider the proposal.

Louise McQueen spoke in opposition to the request, citing concerns about density.

Monica Esparza spoke in opposition to the request, requesting additional time for more engagement with the community.

Amelia Likener spoke in opposition to the request, requesting additional time to work with the community.

Seeing no one else wishing to speak, Mr. Poole closed the public hearing.

Following the motion, several members of the Planning Commission expressed their

support for the proposal.

A motion was made by Commissioner Young, seconded by Commissioner Greenfield, that this ordinance be recommended for approval. The motion carried unanimously.
