Consideration of Continuances and Deletions from Agenda

Richmond 300 overview

This presentation was tabled until the July 23, 2020 PAC meeting due to time constraints.

New road mural on Grace Street (tentative)

An application for this project was not submitted for consideration.

Work Plan Status/Planning Commission

The plan was presented to the Planning Commission on June 1, 2020. A final vote was tabled until the Planning Commission's July 6 meeting. Concerns included the equitable

distribution of locations of existing public art projects and the expenditure of City funds given the ongoing financial concerns of the City as a result of Covid-19. Gary agreed to reach out to Planning Commissioner Mel Law who voiced concern about the budget implications of the plan.

Proposed change to Work Plan

Ashley stressed the need for an "iconic sculpture" to mark this moment in RVA's history and also ensure that the PAC is positioned to take a lead role in "re-envisioning Monument Avenue." She proposed combining two projects on the existing Work Plan— "Artist's Choice" and "Jefferson Davis Replacement Project" to allocate \$1M for a new commission on Monument Ave decoupled from the Jefferson Davis monument.

Matt and Charles who were to serve as leads on the "Artist's Choice" project concurred with the plan.

Several Commissioners urged a role for the community in developing a plan for Monument Avenue moving forward.

Anne encourage consideration of a grant-funded series of temporary art installations to encourage "fruitful and productive conversations" with the larger community and referenced Fairfax's "Imagine Art Here" initiative.

Ashley cautioned the PAC about time implications of developing a temporary art project. Matt mentioned that Emily Smith at 1708 had expressed an interest in a Monument Avenue focused project and Susan mentioned that CultureWorks had also reached out about a multi-disciplinary set of programs on the same theme. Matt will contact 1708 to see if they would be interested in taking the lead on a temporary art initiative to limit the impact on the PAC workload.

A motion was made to approve amending the Work Plan by combining the "Artist Choice" project with the "Jefferson Davis Replacement Project" to create a new project totaling \$1M and described as a new, iconic public commission to be installed somewhere along Monument Avenue.

Project Status Reports

This discussion was tabled until the July 23, 2020, PAC meeting due to time constraints.

PAC public statement

A substantial discussion considered the importance of the PAC making a public statement relative the recent events on Monument Avenue and what role the PAC should undertake moving forward.

Matthew Ebinger described the required process for drafting and distributing such a statement that needs to be managed by the City's Press Office.

Assorted comments of note included: Matt and Charles agreed on the need for such a statement. Gary called such a statement "our coming out party and a declaratory statement of what our values are." Andrea suggested that if the Planning Commission approved the Work Plan, the statement might promote the plan as a whole. Anne felt such a statement could "bring us together" and demonstrate the "healing power of public art."

Anne and Ashley volunteered to draft a statement or bullet points for such a statement that could be forwarded onto the Press Office.
